Introduction:

During the 2003 session of WP.11 the text of Annex 1, Appendix 1, Paragraph 4 was discussed and after investigation by the secretariat it was agreed that a proposal should be introduced for 2004 to restore the original intention of the text.

The proposal in Trans/WP.11/2004/5 from Denmark produces the text in the proper order.

However we feel that the produced “original” text in paragraph 1 still can use some improvement and that the text used in paragraph 2 is not identical to the text in ATP of 7 November 2004 and needs some therefore some adjustments.

Proposal 1: Amend the first paragraph of the proposed text of 2004/5:

A certificate of compliance with the standards shall be issued by the competent authority of the country in which the equipment is to be registered [or] recorded. *This certificate shall on a form conforming to the model reproduced in appendix 3 to this annex.*

Proposal 2: Amend the second paragraph of the propose text of 2004/5:

The certificate, or a certified true photographic copy thereof, shall be carried on the equipment during carriage to be produced whenever so required by control authorities. However, if a *certification* plate, as reproduced in appendix 3 to this annex, is fixed to the equipment, the [*certification*] ~~ATP~~ plate shall be recognised as equivalent to a certificate. ~~ATP-e~~ Certification plates shall be removed as soon as the equipment ceases to conform to the standards laid down in this annex.

Justification:

- (1) Reading the text of the first sentence can indeed raise the question if the equipment is "...registered *and*" or *or*" recorded on a form" By adding a second sentence it becomes clear that the words "registered or recorded" belong together.
- (2) The use of terms for the certification plate in this proposed text is not consistent.
