2. United Nations Economic Commission for Europe workshop on "Urban Transport and Mobility"

By 2050 forecasts predict that there will be 6.9 billion people living in urban areas, comprising 70 per cent of the global population. While the general trend is declining public transport use, some cities have stabilised or slightly increased their public transport usage

levels over the last two decades (London, Madrid, Paris, Vienna, Singapore and Hong Kong).³

The Working Party on Transport Trends and Economics (the Working Party) may wish to consider presentations by invited experts on urban transport and mobility. The relevance of the topic to all transport is explained in the background paper (ECE/TRANS/WP.5/2012/1). The Working Party may wish to adopt conclusions that reflect the presentations and subsequent discussions of workshop participants.
