Comment: In accordance with the Decree No. 7 of the Ministry of Infrastructure of Ukraine of 25 February 2011 concerning measures to implement River Information Services on inland waterways of Ukraine, as amended by Decree No. 53 of the Ministry of Infrastructure of Ukraine of 30 January 2013, the equipment for transmitting electronic messages must comply with the requirements of Resolution No. 60.

61 revised	Recommendations on Harmonized Europe-Wide Technical Requirements for Inland Navigation Vessels (ECE/TRANS/SC.3/172/Rev.1 and Amend.1 and 2)	C. Comment: The competent authority duly authorized in Ukraine to carry out the inspection of inland navigation vessels is the Shipping Register of Ukraine. National Rules for Construction and Classification of Inland navigation Vessels and Rules on ship's certificates of the Shipping Register of Ukraine include the provisions annexed to Resolution No. 61 on "Harmonized Europe-Wide Technical Requirements for Inland Navigation Vessels", with the exception of the provisions of Chapter 23 ("Crews"), except for section 23-9, and of annexes 3 (Safety signs and signals) and 5 (Model of a service record), and provide for the division of inland waterways into navigable zones 1, 2 and 3 in accordance with chapter 1 of the annex to Resolution No. 61. The above-mentioned rules of the Shipping Register of Ukraine include, in the rules on the construction and on the procedure for issuing certificates, the provisions of the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN).
