THE UN AND ITS PARTNERS IN BELARUS ARE WORKING TO ACHIEVE THE SUSTAINABLE DEVELOPMENT GOALS: 17 INTERCONNECTED AND AMBITIOUS GOALS THAT ADDRESS THE MAJOR DEVELOPMENT CHALLENGES FACING PEOPLE IN BELARUS AND AROUND THE WORLD. BELARUS IS ACTIVELY INVOLVED IN THE IMPLEMENTATION OF THE SDGS AT THE NATIONAL LEVEL UNDER THE LEADERSHIP OF THE NATIONAL SDG COORDINATOR AND WITH THE SUPPORT OF THE UN SYSTEM. In 2022, Belarus took 34th place among 163 countries in the ranking of achievement of the Sustainable Development Goals according to the report Sustainable Development Report. It ranks countries based on an overall score that measures progress towards all 17 SDGs.

Belarus scored 76 points out of 100 possible. This score reflects the progress of the country as a whole in implementing the 2030 Agenda for Sustainable Development and can be interpreted as the percentage of SDGs achieved.

In 2023, Belarus ranked 34th among 166 countries in the ranking of achievement of the Sustainable Development Goals according to the Sustainable Development Report. It ranks countries based on an overall score that measures progress towards all 17 SDGs.

Belarus scored 77.5 points out of 100 possible. This score reflects the progress of the country as a whole in implementing the 2030 Agenda for Sustainable Development and can be interpreted as the percentage of SDGs achieved.

REPORTING OF ENTERPRISES ON THEIR CONTRIBUTION TO ACHIEVING THE SUSTAINABLE DEVELOPMENT GOALS IN BELARUS

50 PARTICIPANTS TOOK PART IN THE TRAINING

The purpose of the workshop was to provide key indicators for reporting on the Sustainable Development Goals, which included:

1. Key SDG (Sustainable Development Goals) indicators for enterprise reporting.
2. Reporting by enterprises on their contribution to achieving the SDGs in Belarus.
3. Reporting by SMEs (Small and Medium Enterprises) on their contribution to achieving the Sustainable Development Goals in the Eurasian region.

OBJECT OF THE STUDY: ITILECT LLC

RESEARCH PERIOD: 2020

ITilect LLC is a limited liability company whose main activity is software development. The main office is located in the city of Mogilev, Republic of Belarus. Areas of activity include the Republic of Belarus, South Africa, India, Taiwan, Japan and others. The organization's assets amount to 2,201 thousand rubles (\$853.47 thousand).

The number of people in the organization is 43 people, of which 28 are men and 15 are women.

BELARUS: MEDIUM-SIZED ENTERPRISE LLC "ITILECT"



The results show that the company was able to fully disclose 31 out of 34 indicators. Institutional indicators are not decisive for the company: the founder of the company is its 100% owner and the company has a simple management structure. Considering the business where the company operates, the company owner has focused on environmental (there is waste) and social performance (there is no employee training in the first full year of the company's operation). However, the company plans to convert a number of indicators from zero to positive.
