

In 2021, the CES Task Force developed Guidelines for assessing the quality of administrative sources for use in population censuses












The number of migrants arrived from the CIS countries to Russia for climatic reasons* for 2014-2020 (persons)

Climatic and environmental factors often influence migration decisions indirectly.

Therefore, statistical data reflect the direction of such migration flows, but questions arise in estimating their real scale.
