Tables of **paragraphs** 4 to 7 contain the main requirements for the construction of vehicles so far established and already included into Regulation(s) and Rule(s) by the World Forum. Similar requirements are grouped. For any requirement or group of requirements references are made to the relevant Regulations, identified by the number allocated to them by the 1958 Agreement, to the still valid Recommendations reproduced in **paragraph** 8 and to the Standard Annexes to Regulations reproduced in the annexes to this **Resolution. Annex 7** includes, as complementary information, an updated list of the distinguishing numbers allocated to Contracting Parties by the 1958 Agreement."

* In accordance with the programme of work of the Inland Transport Committee for 2010–2014 (ECE/TRANS/208/, para. 106 and ECE/TRANS/2010/8, programme activity 02.4), the World Forum will develop, harmonize and update Regulations in order to enhance the performance of vehicles. 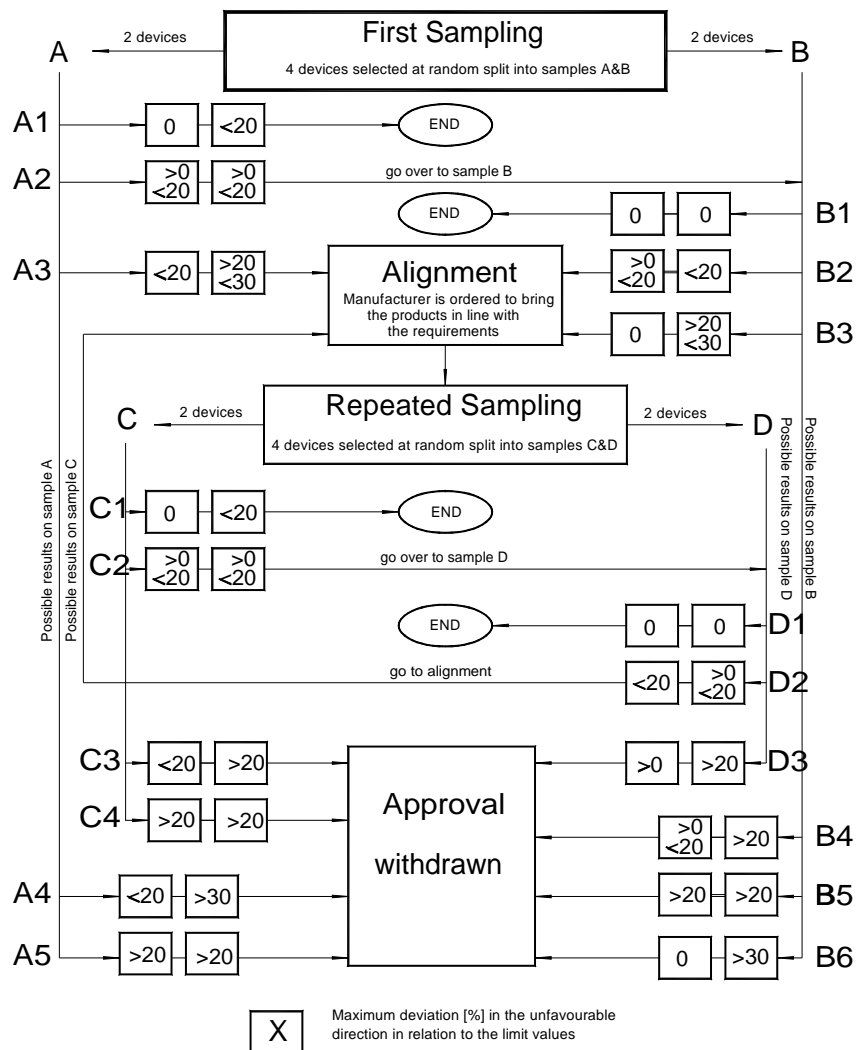
