TO THE ATTENTION OF THE PERMANENT MISSIONS IN GENEVA OF THE COUNTRIES CONTRACTING PARTIES TO THE AGREEMENT CONCERNING THE ESTABLISHING OF GLOBAL TECHNICAL REGULATIONS FOR WHEELED VEHICLES, EQUIPMENT AND PARTS WHICH CAN BE FITTED AND/OR BE USED ON WHEELED VEHICLES, DONE AT GENEVA ON 25 JUNE 1998

Subject: Notifications concerning the 1998 Agreement

Madam, Sir,

I have the honour to refer to the Agreement Concerning the Establishing of Global Technical Regulations for Wheeled Vehicles, Equipment and Parts which can be fitted and/or be used on Wheeled Vehicles, of 1998. As you may know, the purpose of this Agreement, hereinafter called the 1998 Agreement or the Agreement, to which the secretariat of the United Nations Economic Commission for Europe (UNECE) provides the secretariat, is to establish a global process for the development of global technical regulations (gtrs) regarding the safety, environmental protection, energy efficiency and anti-theft performance of wheeled vehicles, equipment and parts.

Such a global process includes an Executive Committee, which is composed of representatives of the Contracting Parties, and which is responsible for the implementation of the Agreement, including the establishment of gtrs under this Agreement (Article 3). The process also includes the creation of a Compendium of candidate global technical regulations, or Compendium of Candidates, (Article 5), and a Global Registry for the establishing of gtrs under the Agreement (Article 6).

As you may know, the Treaty Section of the UN Office of Legal Affairs communicates officially to the Permanent Missions in New York the Depositary Notifications related to the UN legal instruments by e-mail. As the UNECE secretariat is requested to issue Notifications related to the 1998 Agreement, the UN Treaty Section has recommended that the UNECE secretariat use a similar procedure to circulate these Notifications to the Contracting Parties to the Agreement through their Permanent Missions in Geneva.

I would like to inform you that, in accordance with the provisions of the Agreement and in consultation with the Treaty Section of the UN Office of Legal Affairs, the secretariat has now finalized the procedure for communicating to the Permanent Missions in Geneva of the Contracting Parties to the Agreement the Notifications to be circulated by the UNECE secretariat. These Notifications concern the establishment of gtrs in the Global Registry and the listing of candidate

regulations in the Compendium of Candidates, once adopted by the Executive Committee of the Agreement.

In accordance with this procedure, the secretariat circulates the Notifications to the Permanent Missions in Geneva of the Contracting Parties to the Agreement by e-mail messages through the following address: 1998Agreement-Missions@lists.unece.org

This address actually includes the e-mail addresses of all Permanent Missions concerned and that of the secretariat of the Agreement.

Permanent Missions in Geneva of the Contracting Parties to the Agreement are kindly requested to forward to the Treaty Services of the Ministry of Foreign Affairs and/or other competent authorities of their Governments the Notifications as soon as they receive them, for further action as required by Article 7 of the Agreement.

In addition to this electronic system of Notifications, the WP.29 secretariat places all the Notifications received and approved in the WP.29 website.

Also the email sent to the chiefs of the delegations of the Contracting Parties to the Agreement participating to the Executive Committee (AC.3) of the 1998 Agreement is hereto attached.

Accordingly I would like to inform you that all the notifications should be sent electronically to this email address: **1998Agreement-Missions@lists.unece.org** by the Permanent Missions in Geneva of the Contracting Parties to the 1998 Agreement. Additionally, if you could, also a paper copy of the notifications would be appreciated, to be sent at Mr. Juan Ramos Garcia or at my attention at the address reported here at the bottom.

In order to provide you a helpful example, please find attached hereunder the email message and the Notification that the Permanent Mission of Canada has sent us with regard to the Notification of the second status report on global technical regulation No. 1.

Moreover I would inform you that the secretariat needs the indication of the competent Administrative Departments of your Country in the framework of the 1998 Agreement.

I would also need to know who is the person appointed by your Permanent Mission to follow the matter related to the 1998 Agreement and the confirmation that the mail address for the purposes related to the 1998 Agreement (i.e.: notifications delivery) is un.geneva@dfat.gov.au

ESTABLISHMENT OF GLOBAL TECHNICAL REGULATION No. 13

The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 27 June 2013 at its thirty-eighth session, the Executive Committee of the Agreement, in accordance with para. 7.2. of article 7 of Annex B to the Agreement, established by consensus vote (ECE/TRANS/WP.29/1104, para. 98) the following draft global technical regulation:

Global technical regulation on hydrogen and fuel cell vehicles (ECE/TRANS/WP.29/2013/41).

The above global technical regulation was established in the Global Registry as global technical regulation No. 13, entitled "Global technical regulation on hydrogen and fuel cell vehicles", under the symbol ECE/TRANS/180/Add.13.

The following documents are, under the symbol ECE/TRANS/180/Add.13/Appendix 1, appended to global technical regulation No. 13:

Proposal to develop a global technical regulation on hydrogen and fuel cell vehicles (TRANS/WP.29/AC.3/17).

Technical report submitted by the Working Party on Passive Safety on the global technical regulation on hydrogen and fuel cell vehicles (ECE/TRANS/WP.29/2013/42).

Reference is made in this respect to article 6 paras. 6.2., 6.2.5., 6.2.5.2., 6.2.6. and 6.2.7. of the Agreement, which read as follows:

"6.2. <u>Establishing global technical regulations in the Global Registry through harmonization of existing regulations</u>

A Contracting Party may submit a proposal to develop a harmonized global technical regulation concerning elements of performance or design characteristics addressed either by technical regulations listed in the Compendium of Candidates, or by any UNECE Regulations, or both.

- 6.2.5. The Executive Committee shall, using transparent procedures:
- 6.2.5.2. consider the establishment of a recommended global technical regulation in accordance with the procedures set forth in paragraph 7.2. of Article 7 of Annex B. A consensus vote by the Executive Committee in favour of the regulation shall establish the regulation in the Global Registry.
- 6.2.6. The global technical regulation shall be considered to be established in the Global Registry on the date of the consensus vote by the Executive Committee in favour of the regulation.
- 6.2.7. The Secretariat shall, upon the establishment of a global technical regulation by the Executive Committee, append copies of all relevant documentation, including the proposal submitted pursuant to paragraph 6.2.1. of this Article and the recommendations and report required by paragraph 6.2.4.2.1. of this Article, to that regulation."
