DRAFT SUPPLEMENT 10 TO REGULATION No. 54

(Pneumatic tyres for commercial vehicles)

<u>Note</u>: The text reproduced below was adopted by the Administrative Committee (AC.1) of the amended 1958 Agreement at its sixth session, following the recommendation by the Working Party at its one-hundred-and-twelfth session. It is based on document TRANS/WP.29/R.803, as amended TRANS/WP.29/566, paras. 59 and 123).

<u>Paragraph 1. to 1.3.</u>, replace by the following text (including a new footnote  $\pm$ /):

"1. SCOPE

This Regulation covers new pneumatic tyres designed primarily, but not only, for vehicles in categories M $_2$ , M $_3$ , N and O $_4$  and O $_4$ .  $^{\star}/$  However, it does not apply to tyre types identified by speed category symbols corresponding to speeds below 80 km/h.

Paragraph 2.1.1., amend to read:

"2.1.1. The manufacturer;"

<u>Paragraph 2.17.1.3.1.</u>, add the following new nominal rim diameter codes at the end of the table:

## Paragraph 8. and 8.1., amend to read:

"8. CONFORMITY OF PRODUCTION

The conformity of production procedures shall comply with those set out in the Agreement, Appendix 2 (E/ECE/324-E/ECE/TRANS/505/Rev. 2), with the following requirements:

8.1. Tyres approved under this Regulation shall be so manufactured as to conform to the type approved, by meeting the requirements set forth in paragraph 6. above."

Paragraph 8.2. to 8.4.4., should be deleted.

Paragraph 8.4.5., renumber as paragraph 8.2. and amend to read:

"8.2. The authority which has granted type approval may at any time verify the conformity control methods applied in each production facility. For each production facility, the normal frequency of these verifications shall be once every two years."

Annex 1, item 1, amend to read:

"1. Manufacturer's name or trade mark(s) on the tyre type: ...."

Annex 5, Part II, table D, amend the title of the table to read:
