Paragraph 5.1.3.6., correct the reference to AISO 7368" to read A7638":

Paragraph 5.2.1.18.4.1., amend to read:

" ... within the following two seconds; in addition, when the brake control is released, the supply line shall be repressurized."

Note by the secretariat: This amendment had been adopted by GRRF at its fortieth session (TRANS/WP.29/GRRF/40, para. 3), but it has not been included in any draft amendment.
