Introduction

1. The present document provides an overview of national summary reports submitted within the third reporting cycle (2015–2016) by Parties to the UNECE-WHO/Europe Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes and by other States.

2. According to Article 7 of the Protocol on Water and Health, Parties should review periodically the progress made in achieving the targets set pursuant to article 6, paragraph 2, of the Protocol and publish an assessment of that progress. Parties should also provide to the secretariat for circulation to the other Parties, a summary report of the data collected and evaluated and the assessment of the progress achieved.
