Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Spain with the provisions of the Convention in connection with decision-making on a residential development project in the city of Murcia, Spain (Ref. ACCC/C/2008/24)

At its twenty-third meeting (31 March - 3 April 2009), the Aarhus Convention Compliance Committee entered into discussion in an open session on communication ACCC/C/2008/24 (Spain), submitted by the Spanish NGO Asociación para la Justicia Ambiental (AJA - Association for Environmental Justice).

The Committee confirmed that the communication was admissible. It agreed to continue its deliberations on the matter at its next meeting in closed session with a view to finalizing the draft findings and, if appropriate, recommendations at that meeting. The draft findings will then be sent for comment to the Party concerned and to the communicant, in accordance with paragraph 34 of the annex to decision I/7.

Representatives of the communicant participated in the discussion at the twenty-third meeting of the Committee. However, the Committee noted with regret that no representative of the Party concerned was present, despite your Government having been duly notified and invited. The Committee also noted with regret that no response was received from your Government with regard to the communication either before or after the five-month deadline for responding, which (as notified in the secretariat's letter of 7 August 2008) was 7 January 2009.

In response to various questions from the Committee, the communicant has provided a number of additional documents concerning the matters addressed by the communication that we are now forwarding to you.

Finally, we are enclosing (also for the benefit of the communicant who is copied on this letter) a corrected version of the admissibility determination as the previous version contained a small error concerning the date of entry into force.

Please do not hesitate to contact the secretariat if you require any further information concerning the procedure.
