

## March 2007 1stPlanning workshop in the communities

Note: In the course of the community forums the communities pointed out local problems that they wanted to have taken into account in the planning. Therefore workshops were held with the individual communities.

## May 2007 2ndPlanning workshop in the communities

- February 2008 The Regional Planning Council finds that the "Knoflacher Study" (see note below) will not be presented in the Planning Council.
- 10 March 08 Presentation of a route suggestion
- May 2008 Planning exhibition Liezen with publication in the press

*Note: The invitations were issued by posting notices in the communities, mailing in the community newsletters and ads in Kleine Zeitung and Kronenzeitung.* 

June 2008 Planning exhibition Wörschach with the two variants ultimately emerging as the best variants.

Note to "Knoflacher Study":

Dr. Hermann Knoflacher (Professor at the Institute for Traffic Planning and Traffic Engineering at Vienna Technical University) was engaged to conduct traffic studies in Enns valley by opponents of the provincial road planners.

Since the Province never received the relevant documentation, the knowledge of the Province is limited to press reports. Then Dr. Knoflacher was engaged by "citizens' action groups".

The Province does not know who the real employer is (NETT or another group of persons) and what the contract includes.
