Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Denmark with provisions of the Convention in connection with fees for appeals to the Nature and Environment Appeal Board (Ref. ACCC/C/2011/57)

At its forty-second meeting (24-27 September 2013), the Compliance Committee commenced preparation of its draft report to the fifth session of the Meeting of the Parties on how the Party concerned had addressed the Committee's recommendations in the findings concerning communication ACCC/C/2011/57 adopted at the Committee's thirty-sixth session (27-30 March 2012).

By letter of 15 July 2013, the Party concerned had been invited to report on how it had addressed those findings. The Party concerned responded by the requested deadline of 16 September 2013. This response was considered by the Committee in the preparation of its draft report.

Following its deliberations, the Committee agreed to send the draft report, attached, to the parties for their comments prior to the Committee's forty-third meeting (17-20 December 2013) and to take into account any comments received on the draft report at that meeting, before finalizing the report at that meeting for submission to the fifth session of the Meeting of the Parties. You are invited to provide your comments on the draft report by **9 December 2013**.
