We have published the draft National Planning Policy Framework for consultation. This is a key part of our reforms to make the planning system less complex and more accessible, and to promote sustainable growth. We are keen to hear views from all interested parties on the draft and how it might be improved.

Update: The Government has consulted on a draft planning policy for traveller sites. The consultation period ended on 3 August, and a new Planning Policy Statement for traveller sites will be published as soon as possible following due consideration of the consultation responses. The new Planning Policy Statement for traveller sites will be reviewed in the light of all comments received and incorporated into the final National Planning Policy Framework.

As part of this consultation on the National Planning Policy Framework, the Government would welcome responses to the following question:

Do you have views on the consistency of the draft Framework with the draft planning policy for traveller sites, or any other comments about the Government's plans to incorporate planning policy on traveller sites into the final National Planning Policy Framework?
