Annex Communication ACCC/C/2012/76 Bulgaria Questions to parties after the discussion at CC-41

To the communicant:

- 1) To substantiate your allegations, you have provided the Committee with copies of 30 court decisions in Bulgarian. Please provide English translations of the five out of the 30 decisions, which you deem to be the most representative.
- 2) Please provide a copy of the oral statement you made at CC-41.

To the Party concerned:

To substantiate its allegations, the communicant provided the Committee with copies of 30 court decisions which may entail a consistent practice and systemic issue of compliance. Could you comment on the apparent practice that seems to support the communicant's allegations? Would you be able to provide the Committee with significant number of examples that show that the practice followed is actually different?
