The text has been drafted on the assumption that your Government agrees with the Committee making recommendations in accordance with paragraph 36 (b) of the annex to decision I/7. If this is not the case, please indicate this in your reply. Given the lengthy timeframe until the sixth session of the Meeting of the Parties, Committee considers that the making of recommendations directly to the Party concerned, coupled with timely action by the Party to implement such recommendations, would enable the matters to be resolved in the most expeditious way.
