PROPOSED HINKLEY POINT C NUCLEAR POWER STATION, SOMERSET, UNITED KINGDOM

Thank you for your letter of 19 October 2012 regarding the application for consent to construct the Hinkley Point C nuclear power station.

As requested I enclose a "memory stick" containing all the application documents, including the Environmental Statement, as submitted by NNB Genco as part of the Hinkley Point C application in October 2011. The memory stick also contains post-submission changes, such as errata to the documents submitted in the application. There are further documents that should be read alongside those documents which are available, along with all other documentation, on the Hinkley Point C project website at http://infrastructure.planningportal.gov.uk/projects/South%20West/Hinkley-Point-C-New-Nuclear-Power-Station/.

Submission/Application%20Documents/Reports/3.1%20-%20Consultation%20Report/3.1%20-%20Consultation%20Report.pdf. In addition to the applicant's consultation, just short of 1,200 representations were made to the Examining Authority (Planning Inspectorate) and 13 hearings were held.

I would also draw your attention to the European Commission's views on the project in accordance with Article 43 Euratom of 12th July 2012 and the applicant's notification to the Commission for the purposes of those views (available at
