COURT FEES:

1. The initial court fee is due in the following amounts:
a) for judicial proceedings of a value of up to 1.100 euro, the fee is 43 euro ();
b) for judicial proceedings of a value from 1.100 to 5.200 euro, the fee is 98 euro ();
c) for judicial proceedings of a value form 5.200 to 26.000 euro, the fee is 237 euro ();
d) for judicial proceedings of a value from 26.000 to 52.000 euro, the fee is 518 euro; ()
e) for judicial proceedings of a value from 52.000 to 260.000 euro, the fee is 759 euro;
f) for judicial proceedings to a value from 26.000 to 520.000 euro, the fee is 1.214 euro;
g) for judicial proceedings to a value above 520.000 euro, the fee is 1.686 euro;
1-bis. In case of appeal, the initial court fee of paragraph 1 is increased of half the amount and is doubled in in case of recourse in front of the Court of Cassation

1-c. If the appeal, even incidental, is fully rejected or declared inadmissible or the juridiction is declined jurisdiction, the part who proposed it is required to pay an additional amount of fees equal to that due to the same appeal, principal or incidental, pursuant paragraph 1-bis.

6-bis. The initial court fee for actions brought before the Regional Administrative Courts and the Administrative Court of Appeal are due in the following amounts:

6. (...)

a) for the judicial proceedings under Articles 116 and 117 of the Legislative Decree, July 2, 2010, n. 104, (...) the fee amounts to 300 euro. No inital court fee is due for actions referred to in Article 25 of Law no. 241 of 1990 against the refusal of access to information pursuant to Legislative Decree 19 August 2005, n. 195, implementing Directive2003/4 / EC on public access to environmental information;

- c) for proceedings to which may be applied the summary trial, common to certain matters pursuant to Book IV, Title V, of the Legislative Decree, July 2, 2010, n. 104 and to other provisions which explicitly require the application of this form of trial, the initial fee is of 1.800 euro;
- d) for proceedings provided by Article 119, paragraph 1, letter a) and b) of the Code in Annex 1 to the legislative decree of July 2, 2010, no. 104, the court fee is of 2,000 euro if the value of the dispute is equal to or less than 200.000 euro; for those of worth from 200.000 euro and 1,000,000 euro the court's fee is of 4.000 euro while those worth more than 1.000.000 euro the fee is of 6.000 euros. (...)
- e) in all other proceedings not covered by previous provisions and for appeals to the President of the Republic in the cases allowed by the law, the fees due amount to a total of 650 euro.

6-bis. 1. The fees referred to in subparagraphs a), b), c), d) and e) of paragraph 6-bis increase of half of the amount if the lawyer does not indicate his email address and his certified fax number, in accordance with Article 136 of the Code of Administrative Procedure of the legislative decree July 2, 2010, n. 104, or if the party fails to provide his tax code when filing his claim. The payment of these contributions should in any event be beared by the unsuccessful party, even in the case of compensation of judicial fees and even if the party did not join the proceeding. For the purpose aforesaid, the losing party is determined when the decision becomes definitive. For the purposes of this paragraph appeals include the main one, the incidental one and the additional grounds that introduce new questions. (...)

art. 119 – Equal treatment for foreigners and stateless person

1. The treatment envisaged for Italian citizen is granted also to foreigners, legally residing in Italy at the time of the rise of the legal relationship or of the happening of the event object of the initiating proceeding as well as to stateless people and entities or non profit organizations which do not exercise economic activities.
