

DUMPING AT SEA ACTS 1996 TO 2010

APPLICATION SUBMITTED BY PORT OF CORK COMPANY FOR THE DISPOSAL OF DREDGE MATERIAL AT SEA FROM MAINTENANCE DREDGING OF CORK HARBOUR DURING THE PERIOD FROM AUG 2014 TO DEC 2020

NOTICE IS HEREBY GIVEN THAT PORT OF CORK COMPANY has submitted an application to the Environmental Protection Agency for a permit under Section 5 of the Dumping at Sea Acts 1996 to 2010. The application is for the disposal of a maximum of 1,249,600 tonnes of dredge material (consisting of primarily soft sity sediments) from maintenance dredging in Cork Harbour. The proposed marine disposal site is located approximately 8km south of the entrance to Cork Harbour at Roche's Point. Dredging over the maintenance period will be by various methods including Trailer Suction Hopper Dradging Water Injection Dredging and Bed evelling. The Trailer Suction Hopper Dredger will be used to dispose of the dredge material.



Any person wishing to make a submission, or submit observations, in respect of the granting of a permit for this proposed project should do so in writing to the Environmental Licensing Programme, Office of Climate, Licensing & Resource Use, Environmental Protection Agency, PO Box 3000, Johnstown Castle Estate, County Wexford within I month of the publication of this notice, i.e. 5pm on 26th February 2014. Persons making a submission, or submitting observations, in respect of this project are advised that their comments will be forwarded to the applicant for comment and will be published on the Agency's website www.epa.ie.
