Dear Mr. Alge, dear Ms. Lueger,

Re: Communication to the Aarhus Convention Compliance Committee concerning compliance by Czechia regarding public participation and access to justice in connection with the life-time extension of Dukovany Nuclear Power Plant (ACCC/C/2016/143)

I write to inform you that the Aarhus Convention Compliance Committee proposes to hold the hearing to discuss the substance of communication ACCC/C/2016/143 at its sixty-fourth meeting to be held at the Palais des Nations, Geneva, on 1-5 July 2019.

The hearing of the above communication is scheduled for **Wednesday**, **3 July 2019**, starting at 10:30 am and concluding by 4:30 pm.

In accordance with chapter IX of the annex to decision I/7 of the Meeting of the Parties to the Convention, both parties are entitled to participate in the hearing on the subject matter of the communication, though not in the preparation or adoption of any findings, measures or recommendations of the Committee.

According to the Committee's normal practice, the hearing of the communication, which will be held in open session, will be interspersed with at least one closed session in which the Committee will begin the process of preparing draft findings. It is envisaged that the first part of the hearing in open session will take the following form:

- introduction by the Chair;
- opening of the hearing by the curator for the case (10-15 minutes);
- concise presentations by the communicant and by the Party concerned (10-15 minutes each);
- questions from Committee members, responses from the Party concerned and the communicant (30 minutes);
- comments from other observers at the invitation of the Chair (10 minutes);
- final comments by the communicant (5-10 minutes);
- final comments by the Party concerned (5-10 minutes).

Further details concerning the timetable for the hearing will be provided in the provisional timeline for the meeting to be published on the meeting webpage nearer to the time of the meeting.



During the second part of the hearing (i.e. following the closed session), the Committee may pose additional questions to the parties or invite reactions to any tentative conclusions it has reached. In accordance with its usual practice, the Committee may also invite the Party concerned to indicate whether, should the Committee ultimately find the Party to be in non-compliance, it would agree to the Committee making its recommendations to it directly, in accordance with paragraph 36(b) of the annex to decision I/7.

I would be grateful if you would confirm by **10 May 2019** that a representative of the communicants will participate in the hearing. All participants are encouraged to cover their own costs as far as possible, but in case you would require financial support to cover travel and subsistence costs for one representative in order to be represented at the meeting, please notify me by return and in any case no later than **4 June 2019**. Thereafter, each participant wishing to attend the meeting should register online at <a href="https://uncdb.unece.org/app/ext/meeting-registration?id=ivjZQC">https://uncdb.unece.org/app/ext/meeting-registration?id=ivjZQC</a> before **26 June 2019**.

In this regard, it is expected that both the Party concerned and the communicant will participate in the hearing in person. Each party should ensure that its representative(s) taking part in the hearing have the necessary competence to answer the Committee's questions within the scope of the case.

The Committee has indicated that the meeting should not be used as an occasion to introduce substantial amounts of information that could or should have been provided to it at an earlier stage, unless this is unavoidable (e.g. because it concerns very recent developments). Should you wish to present any further substantial written material related to the matter, you should take into account that where such information is received less than two weeks before the scheduled meeting, it is doubtful whether the Committee would be able to take it into consideration when it is discussing the matter, even where the information is provided in English.
