

The Act No. 258/2011 Coll.
of 12. July 2011

**on Permanent Storage of Carbon Dioxide in Geological Structures and amending
some other acts**

National Council of the Slovak Republic has adopted this act, as follows:

Article IX

Act No. 24/2006 Coll. on environmental impact assessment and amending some other acts, as amended by Act No. 275/2007 Coll., Act No. 454/2007 Coll., Act No. 287/2009 Coll., Act No. 117/2010 Coll. and Act No. 145/2010 Coll., as follows:

1. In annex No. 8, the table No. 1 Mining Industry added item No. 17, as follows:

2. In the annex No. 8, table No. 4 Chemical, Pharmaceutical and Petrochemical Industry after the item No. 13, the new item No. 13a, is added, as follows:

13a.	Pipelines for the transport of carbon dioxide and connected compression stations (1) with the lightness (2) or length	from 800 mm from 40 km	to 800 mm to 40 km

3. In the annex No.8, the table No.8 Other Branches of Industry, added item No. 11, as follows:

11.	Equipments for the capture of carbon dioxide flow for the purposes of permanent storage of carbon dioxide into the geological structures	from 1 500 000 t/year	to 1 500 000 t/year

4. Annex No. 13 has been added by points 18 and 19, as follows:

"18. Equipments for the capture of carbon dioxide flow for the purposes of permanent storage of carbon dioxide into the geological structures.

19. The pipes with a large lightness for the transport of carbon dioxide, and connected compression stations."

5. Annex No. 16 has been added by the point 3, as follows:

"3. Directive of the European Parliament and the Council No. 2009/31/EC of 23 April 2009 on the geological storage of carbon dioxide and amending the Council directive 85/337/EEC, the directives of the European Parliament and the Council 2000/60/EC, 2001/80/EC, 2004/35/EC, 2006/12/EC, 2008/1/EC and Regulation (EC) No. 1013/2006 (OJ L 140, 5. 6.2009)."

Article XII

This Act shall enter into force on the date of the statement.
