PRTRs in Action:

Pollutant Release and Transfer Registers as a tool for SAICM and Multilateral Environmental Agreements implementation

One of the major outcomes of the Kiev Ministerial "Environment for Europe" Conference was the adoption and signing of the Protocol on Pollutant Release and Transfer Registers (PRTRs) under the Aarhus Convention. The objective of the Protocol is to guarantee access to information on releases and transfers of certain polluting substances through registers that can be searched via the Internet. Such registers facilitate public participation in decision-making, strengthen governance of chemical management systems, and contribute to the prevention and reduction of environmental pollution.

But what exactly are PRTRs and how can they help with implementation of SAICM and Multilateral Environmental Agreements?

WHAT are PRTRs and how do they work in practice? What experience is already available in the Western and Eastern parts of UNECE region?

WHY should States implementing SAICM establish such registers? - What are the benefits of PRTRs for the various stakeholders, including governments, the public, environmental NGOs and the private sector?

HOW are PRTRs developed and what are the next steps to take at the national, regional and international levels to implement and further develop this tool and take advantage of its many opportunities?

The Side event will aim to provide answers to these questions and demonstrate some of the opportunities PRTRs offer for countries implementing SAICM and Multilateral Environmental Agreements.

After presentations by the panellists, there will be time for questions and discussion.
