Dear Ms. Taghizade and Ms. Yusifova,

At its third session (Oslo, 25–27 November 2013), the Meeting of the Parties to the Protocol on Water and Health supported the decision of the Compliance Committee that it may, based on its assessment of the results of the second reporting exercise under the Protocol or other information available to the Committee, invite a Party or a small group of Parties having identical or almost identical implementation problems to engage in a Consultation Process (see enclosed terms of reference).

At its tenth meeting (Geneva, 25 November 2014), having discussed various possible candidates for the Consultation Process, the Committee decided, based on the criteria outlined in the report of the meeting, to invite Albania, Azerbaijan, Bosnia and Herzegovina (as an observer) and Croatia to engage in the Process.

The objective of the Consultation Process is to assist Parties in implementing the provisions of the Protocol on Water and Health. It consists of advice and assistance, which may vary depending on the specific conditions and needs of the Party involved. It can address scientific, technical, legal and administrative issues. The Consultation Process is not a compliance review procedure. Hence, it is not of an inquisitive nature and its objective is not to establish whether a Party is non-compliant. The procedure is guided by the same principles guiding the work of the Compliance Committee, i.e., that it be simple, facilitative, non-adversarial and cooperative.
