Past cooperation

Background

In November 2012 the Parties to the UNECE Water Convention adopted Decision VI/5 calling for a close cooperation between UNECE Water Convention and the UNESCO International Hydrological Programme (UNESCO-IHP) with the objective of promoting the protection and the reasonable, equitable and sustainable use of transboundary groundwater, through the exchange of experience and the organization of joint activities. In view of the risk of unsustainable use of these precious resources, UNECE and UNESCO-IHP joined forces to address the challenge of the implementation of the UNECE Water Convention in this area.

The cooperation builds on earlier cooperation, started in the 1990s, in particular in pilot projects, preparation of the component on aquifers of the UNECE assessments on transboundary waters, and dissemination of monitoring guidelines.

The cooperation between UNECE and UNESCO-IHP in the last two years focused on the promotion of the principles of the UNECE Water Convention and its Model Provisions on Transboundary Groundwaters, in particular in the framework of the area of work "Promoting the management of transboundary aquifers" of the Eighth Phase of the IHP (IHP-VIII, 2014-2021). The cooperation included exchange of experience, preparation of material, organization of regional consultations and joint activities as well as seminars for both parties and non-parties of the UNECE Water Convention. Examples of such activities are listed in the Annex to this document.

Such fruitful cooperation has been supported by the contribution of the UNESCO-IHP global network which includes Centres, Chairs, IHP National Committees, the "International Shared Aquifers Resources Management (ISARM)" Programme Focal Points, and in particular, the UNESCO International Groundwater Resources Assessment Centre (IGRAC). UNESCO-IHP network offered scientific contribution and support in capacity-building activities aimed at raising awareness of the importance of the UNECE Water Convention as a global instrument and the implications of its implementation in the protection and the reasonable, equitable and sustainable use of transboundary groundwater resources.

The celebrations of the International Year of Water Cooperation (2013), on behalf of UN-Water, were organized by UNESCO-IHP in collaboration with UNECE. This included in particular a regional

consultation of the GEF-funded "Groundwater Governance" project, held in The Hague, the Netherlands, from 19 to 21 March 2013. The meeting, organized by UNESCO-IHP in cooperation with UNECE, counted with the participation of more than 100 participants. UNECE regional priorities and needs were presented and discussed, with broader aim of improving governance for groundwater resources and aquifers, raising awareness on a global groundwater agenda, and building partnerships across decision makers and stakeholders. UNESCO-IHP also counted with the support of UNECE to organize other milestone events of the Year, such as the High-Level International Conference on Water Cooperation (August 2013, Dushanbe, Tajikistan), the Strategic and High-Level Meeting on Water Security and Cooperation (September 2013, Nairobi, Kenya), the Budapest Water Summit (October 2013, Budapest, Hungary) and the Closing Ceremony of the International Year of Water Cooperation (December 2013, Mexico City, Mexico).

Additionally, different seminars and workshops were organized jointly, e.g. at the World Water Week, in 2013, 2014 and 2015. UNESCO-IHP contributed to UNECE's outreach and awareness raising events such as national and regional workshops held in Amman, Jordan (March 2015) and in Beirut, Lebanon (February 2015).

Transboundary contexts

Trade-offs and uses of water, energy and food, as well as overlaps and unclear responsibilities related their management can cause friction between riparian states. Recognizing these challenges, the UNECE (Task Force on the Water-Food-Energy-Ecosystems Nexus) and UNESCO (Food, Energy, Environment, and Water Network – FE2W) have started exchanging experience in the assessment and study of the water-food-energy-ecosystems nexus in transboundary basins around the world. Cooperation has allowed seeking new opportunities for additional sharing of practical solutions for improving security and reconciling different needs in transboundary basins.

Moreover, other joint activities included the compilation of good practices in transboundary water cooperation and the creation of an online database enabling its constant enrichment. These activities were implemented under the umbrella of the UN-Water Transboundary Waters Thematic Priority Area (TPA), which UNESCO-IHP and UNECE co-coordinate jointly. A flyer summarizing the results of the good practice collection was presented at the 7th World Water Forum in the Republic of Korea in April 2015.

Communication and Outreach

UNESCO-IHP has also supported the preparation of the Arabic version of the Model Provisions on Transboundary Groundwaters of the UNECE Water Convention (translation and printing). This publication is being distributed and promoted widely, in particular in the seminars held in the Arab region.

Capacity-building trainings

Both UNESCO-IHP and the UNESCO IGRAC Centre regularly participate in the UNECE Water Convention meetings in Geneva. In particular, and in the framework of the capacity building activities of the Governance of Groundwater Resources in Transboundary Aquifers (GGRETA) Project, funded by the Swiss Agency of Development and Cooperation (SDC), UNESCO-IHP presented to recipient countries the UNECE Water Convention during International Water Law seminars of the project (Gaborone, Botswana; May 2015; Tashkent, July 2015) and facilitated the UNECE Water Convention's secretariat participation in such events to share experience. Furthermore, UNESCO supported the participation of experts from the Ministry of Environment of Guatemala, the Ministry of Agriculture, Water Affairs and Forestry of Namibia, the Ministry of Minerals, Energy, and Water Resources of Botswana, the Committee of Geology and Use of Mineral Resources of Kazakhstan and the State Committee on Geology and Mineral Resources of Uzbekistan, among others, in different workshops organized under the UNECE Water Convention.

Future plans for cooperation

Promotion of International Water Law

Valuing the fruitful past and on-going activities conducted along with UNECE, UNESCO-IHP aims on consolidating efforts on future joint activities. UNESCO is determined on continuing to support and promote the principles of the UNECE Water Convention and the Model Provisions on Transboundary Groundwater, by providing its expertise and taking the lead in the implementation of further actions focused on groundwater, for instance by supporting the promotion and the application of the UNECE "Guidance Note on the Benefits of Cooperation".

UNESCO-IHP is thus ready to collaborate further with UNECE Water Convention, as expressed in the Decision VI/5 "with the shared objective to promote the protection and the reasonable, equitable and sustainable use of transboundary groundwaters, through the exchange of experience and the organization of joint activities", within the framework of the Internationally Shared Aquifers Resources Management (ISARM) Programme, and with close involvement of the UNESCO IGRAC Centre.

UNESCO-IHP, in collaboration with the UNESCO IGRAC Centre, is also ready to participate to the development of a concept for a third comprehensive assessment as planned in the UNECE Draft programme of work for 2016-2018. The main achievements of the Global Environment Facility (GEF) Transboundary Waters Assessment Programme (TWAP), for which UNESCO was in charge of the groundwater component, and the UNESCO Internationally Shared Aquifer Resources Management programme, are particularly relevant for this work. Related to TWAP, UNESCO and UNECE also cooperated, with UNECE Water Convention Secretariat providing input to the identification of case studies and refining the approach to the groundwater component, as well as facilitating country contacts.

Other common activities will be also developed under the UNECE Programme area 4: Adapting to climate change in transboundary basins, particularly regarding groundwater assessment.

Sustainable Development Goals (SDGs)

UNESCO-IHP and UNECE will collaborate in the monitoring of the SDG on Water which includes a target mentioning transboundary water cooperation (target 6.5) through potential two indicators: a broader one measuring Integrated Water Resources Management and a more specific one measuring transboundary water cooperation.
