Catherine (Kiki) Brölmann Short *Curriculum Vitae*

Dr Catherine Brölmann is an associate professor of international law at the University of Amsterdam. One of her specializations is the law and governance of water resources and international environmental treaty regimes. She teaches International Water Law, is involved in research on the implementation of the right to water in national legal systems, and has published (mostly in Dutch) several articles and op-ed on the law regarding water and sanitation, including on pertinent Dutch case law. She has been concerned with water law and governance also eg as a member of the steering group of the government-funded project (2008-) of the organization Both Ends - "the right to water at the World Bank" -, and as a participant in several expert meetings on water and sanitation organized by the Dutch ministry for Foreign Affairs. She has recently participated in the founding session of the Surrey Centre on Transboundary Aquifers Governance (2010) and is co-editor of an ensuing special issue of the journal *ICLRev* with essays on Transboundary Aquifer Law.

Catherine Brölmann has worked for an extensive period on secondment to the legal division of the Dutch Ministry of Foreign Affairs, and has acted as an amicus curiae to the Court of Appeal in The Hague. She is editor on the board of the journal *International Community Law Review (ICLRev)*; she is i.a. member of the working group on Sustainable Development and Human Rights of the *Dutch Lawyers' Committee for Human Rights* and delegate member of the Studygroup on Responsibility of International Organisations of the *International Law Association.*

Research Fellowships include the University of Helsinki (diploma of the Summer Seminar 1998); the Lauterpacht Centre, University of Cambridge (2004); Queen Mary College, University of London (2006). Ms. Kocsis-Kupper received a law decree from Eötvös Loránd University, Budapest, complemented with a postgraduate degree in environmental law. She is currently enrolled in a PhD program in the same University. She has also completed an EPCEM course in the Vrije Universiteit Amsterdam. Her main area of expertise is in European and international environmental law and management.

The current occupation of Ms. Kocsis-Kupper is managing director of an international consulting company, where her main activity is project management and research on European and international environmental law. Projects include legislation on greenhouse emission, liability of transboundary pollution, sustainable water management in the five Tisza riparian countries, waste management issues, and wildlife protection.

Ms. Kocsis-Kupper acts as a monitoring consultant and regional coordinator of the Central European Team under Astrale. She is part of the external monitoring team for the European Commission DG Environment LIFE Unit, monitoring LIFE projects in Hungary, and coordinates environment and nature monitors in Slovakia, Czech Republic, Poland and Romania. The task covers technical and financial monitoring of the projects and the participating companies.

Ms. Kocsis-Kupper gives lectures on environmental law and international environmental law in Eötvös Loránd University Law Faculty, Budapest, and Pázmány Péter University, Budapest.

Her previous work experience includes legal advisory to the Hungarian Government concerning the Tisza-Szamos cyanide pollution. Veit Koester is master of Law and Administration; Barrister; External professor at Roskilde University Centre in Denmark and visiting professor at United Nations University, Institute of Advanced Studies, Japan. He is also a guest lecturer in international environmental law at Copenhagen University, Faculty of Law, Denmark.

He serves as a consultant to various projects. He is (since 2003) chairperson of the Compliance Committee of the Aarhus Convention on Access to Information, Participation in Decision-making and Access to Justice in Environmental Matters; and was until 1 January 2009 also chairperson of the Compliance Committee of the Cartagena Protocol on Biosafety (he chaired the Working Group of the Parties which negotiated the Protocol). He is a member of the IUCN Commission of Environmental Law, of the European Council of Environmental Law as well as of the International Council of Environmental Law.

Veit Koester has served as elected chairperson or vice-chairperson at numerous COPs and other intergovernmental negotiating conferences as well as having represented the EU Presidency at such conferences. He has published numerous articles in Danish and English on Danish, EC and international environmental law (especially on biodiversityrelated MEAs and the Aarhus Convention).

Veit Koester has received i.a. UNEP – the Global 500 Award (1996), the Elisabeth Haub Award (ICEL and Pace University) for "Environmental Diplomacy for the year 2000", the CITES Golden Pin (2002) and has been designated as a "Wetland of International Importance Person in 2002 ("Person No. 3").
