UNECE TECHNICAL COOPERATION ACTIVITIES IN 2003: AN OVERVIEW

Note by the Executive Secretary

Introduction

- 1. Technical cooperation is an important supporting instrument for implementing the UNECE core programme activities. It is aimed at assisting countries of the UNECE region in the application of agreed norms and standards, and implementation of relevant recommendations and legally binding instruments through strengthening their national institutional and human capacities, and supporting the development and implementation of relevant national policies, regulations and actions. It also helps interested countries in addressing cross-border and subregional issues of mutual interest, which are relevant to the UNECE mandate and programme of work.
- 2. In 2003, technical cooperation activities were implemented by the regular UNECE staff as well as by the Regional Advisers. As in earlier years the prevailing mans of implementing technical cooperation services have been capacity-building workshops, seminars, study tours, policy advisory services and field projects. The main sources of funding were the resources made available for UNECE from the UN Regular Budget (mainly the Regular Programme for Technical Cooperation and the UN Development Account), extra-budgetary resources, usually contributed to trust funds, as well as various ad hoc and in-kind contributions.
- 3. This report contains an overview of 2003 technical cooperation activities and some recent trends in the work of the UNECE Regional Advisers, technical cooperation projects carried out under local and general trust funds, UNECE cooperation with sub-regional country groupings and initiatives, as well as with other United Nations agencies and regional organizations.

4. It should be noted that during 2003 the UNECE reform process which has continued included the formulation of new strategic approaches to technical cooperation aimed at raising its overall effectiveness and meeting the new realities in the UNECE region, including developments resulting from the forthcoming EU enlargement. Moreover, technical cooperation in the United Nations as a whole was subject to a review by the General Assembly, as part of the on-going broader reform of the Organisation. Hence this report should be seen in the context of the Executive Secretary's report on "The UNECE Reform" (E/ECE/1411) and "UNECE Technical Cooperation Strategy" (E/ECE/1411/Add.1).

I. Technical cooperation activities implemented by the UNECE Regional Advisers

- 5. In 2003, the activities of the Regional Adviser on Sustainable Energy were concentrated on the development and implementation of energy efficiency projects and capacity building, including: the "Energy Efficiency 21" project; the SPECA project on "Rational and Efficient Use of Energy and Water Resources in Central Asia"; project on "Biomass Energy for Heating and Hot Water Supply in Belarus"; project on "Reducing Barriers to Greenhouse Gas Emissions Mitigation" in Kazakhstan and Ukraine; project on "Energy Efficiency Investment Project Development for Climate Change Mitigation"; project on "Energy Efficiency and Energy Security in CIS"; projects on "Removing Barriers to Implementation of Energy Efficiency Improvements" and on "Opportunities to Join the Kyoto Protocol to UNFCCC" in Belarus. Within these projects the training courses and workshops were organized on project development, financial engineering and business planning; creating an electronic regional information network for national institutions in Central Asia; on energy efficiency and energy security in CIS countries; and on legal and normative procedures needed in case of accession of Belarus to the Kyoto Protocol. Capacity building activities included the creation of Centres on Energy Efficiency and Cleaner Production in Kazakhstan and Kyrgyzstan, as well as the establishment of Energy Efficiency Demonstration Zones in Kazakhstan, Kyrgyzstan and Ukraine.
- 6. The activities of the Regional Adviser on Entrepreneurship and SMEs were concentrated on the following major areas: development of national SME policies and exchange of experience on best practice in this area; quality and environmental management systems for enterprises; development of TNC-SME linkages; youth and women's entrepreneurship; and SME financing. During 2003 advisory services on national SMEs policies were provided in particular to Belarus, the Republic of Moldova and the South Caucasus transition economies. The UNECE report on SMEs in transition economies in 2000-2001 was issued. Experience on best practices in the development of entrepreneurship was exchanged during the Forum devoted to the achievements of the SME sector in Croatia and Slovenia. Advisory services were provided during workshops on promotion of SMEs: development of youth entrepreneurship; networking for SMEs; SME development in the South Caucasus transition economies; CIS Forum on Youth; and the Second UNECE Forum of Women Entrepreneurs.
- 7. The activities of the Regional Adviser on Environment were focused on the development and implementation of water-related projects and activities; advice on the development of national environmental policies and sub-regional cooperation, as well as ratification and implementation of the UNECE Environmental Conventions. These included: the SPECA project on "Rational and Efficient Use of Energy and Water Resources in Central Asia" (carried out jointly with the Regional Adviser on Sustainable Energy); advisory assistance in the development of an initiative

"Water, environment and security in Central Asia" for the Kiev Conference of Environmental Ministers (May 2003); a project "Support for the Creation of a Commission on the Chu and Talas rivers between Kazakhstan and Kyrgyzstan"; advisory services on air pollution monitoring and modelling; development of cooperation between countries in the Sava river basin; transboundary water cooperation in the East European and Central Asian countries; modernization of governance systems in the fields of health, water and waste management in the South Caucasus; and participation in Environmental Performance Reviews in Georgia and Azerbaijan. The Regional Advisor arranged a seminar on "Environment, water and security in Central Asia", and a workshop on "Transboundary water cooperation in the Eastern Europe, Caucasus and Central Asia". Capacity building activities included those aimed at the establishment of a Southeast European sub-regional Legal Experts Network for supporting acceptance and implementation of Multilateral Environmental Agreements (MEA).

- 8. The work of the Regional Adviser on Investment Promotion was focused on the promotion of public-private partnerships; protection and enforcement of intellectual property rights; land for development programme; and economic and environmental dimensions of security. Advisory services were provided, in particular during the UNECE-REAG Land for Development Programme Forum; Forum on Good Governance in PPP for Infrastructure Development, annual session of the UNECE Intellectual Property Advisory Group; annual OSCE Economic Forum; and UNECE/OSCE seminar on "New Strategies for Enhancing Security in Economic and Environmental Dimensions".
- 9. The activities of the Regional Adviser on Statistics were concentrated on assisting economies in transition in the implementation of international statistical standards and statistical capacity building. In particular, advisory services to statistical capacity building were provided, in cooperation with the staff of the Statistical Division, to the Republic of Moldova, and Serbia and Montenegro in the development of new statistical legislation; to Albania in enhancing its statistical capacity to produce MDG-related indicators; to Bosnia and Herzegovina in assessment of its statistical system; to The former Yugoslav Republic of Macedonia in the preparation and conduct of the population and housing census; and on national accounting issues of concern to transition economies Advisory services were also provided during the UNECE/World Bank seminar on the application of the fundamental principles of official statistics and under the UNECE/UNDP project on human development statistics and social trends reporting in Central and Eastern Europe and CIS.
- 10. The activities of the Regional Adviser on Trade Facilitation were mainly concentrated on providing advisory services to the transition economies of South-East Europe, in particular within the SECI/Stability Pact framework, namely: UNECE/SECI project on "Visa Regime Review"; UNECE/UNODC/SECI joint project on "Professional Exchange and Training of Law Enforcement Personnel in the SECI/SP Region"; "Development of the Post-clearance Audit Function in the Customs Administrations of the SECI/SP Region" project; as well as "Bulgaria Customs Reform" project; promotion of "UNeDocs" project; exploring possibilities for establishing pilot projects on "UNeDocs" and "Single Window"; and support for the e-Southeastern Europe Initiative.
- 11. The activities of the Regional Adviser on Transport were concentrated on providing advisory services to transition economies under the SPECA project on "Development of Transport

Infrastructure and Border Crossing Facilitation"; Trans-European North-South Motorway (TEM) and Trans-European Railway (TER) projects; UNDA project on "Capacity Building in Developing Interregional Land and Land-Cum-Sea Transport Linkages"; and other projects related to the development of Pan-European transport corridors and Euro-Asian transport links. Advisory services were also aimed at promoting the UNECE legal instruments in the field of transport and cooperation with the private sector within the PPP concept for assistance in project implementation.

- 12. Overall, the level of funding for technical cooperation activities carried out by the Regional Advisers in 2003 under the Regular Programme of Technical Cooperation (Section 21) remained approximately at the same level as compared with 2002. The number of Regional Advisers, however, which totalled 10 at the start of the biennium, was down to 7 in 2003 with the retirement of two (one Regional Adviser on Transport in 2002 and one on Development and Policy Issues in 2003) and the non-replacement of the Regional Adviser on Gender Issues since this area of work has already been provided for under Section 18 of the Regular Budget. As the separation costs of the two long-serving retired Regional Advisers had to be absorbed from the fixed level of funds available under Section 21, no immediate replacement for them was possible. Expenditures incurred under Section 21 include salaries and related costs (i.e. entitlements and separation/repatriation costs) of Regional Advisers and costs of regional advisory travel.
- 13. The sectoral structure of financial resources available from Section 21 of the regular budget in 2002 and 2003 is given in Table 1. As can be seen from the table, the majority of resources (47.5%) were allocated to advisory services under the mandates of the Committee for Trade, Industry and Enterprise Development (four Regional Advisers were counted under this broad area) followed by the activities mandated by the Inland Transport Committee (16.8%).

14. The geographic structure of the RA activities undertaken in 2003 as a percentage of the total advisory missions is presented in Table 2. While the geographic distribution of regional advisory services missions among the transition economies in 2003 did not change radically as compared with 2002, (see Table 3 in document E/ECE/1403), the number of regional advisory

service missions fell substantially: 73 missions during January to September 2003 compared with 110 missions during the same period in 2002 (i.e. 34% less). This was attributable to the fact that less funds were available under Section 21 for regional advisory travel since more resources had to be earmarked to cover salaries and related costs of Regional Advisers due to the high cost of separation of Regional Advisers (as mentioned in paragraph 12 above), and to the weakening of the US dollar. Regional advisory travel expenditures under Section 21 totalled US\$ 133,439 in 2002 and only some US\$ 94,600 remained available in 2003. It should be noted, however, that in addition to the resources available under Section 21 of the Regular Budget, part of the missions was covered from extra-budgetary resources contributed by donor countries and organizations.

- * RA missions undertaken to other countries that in many cases served as a venue for capacity building activities and policy advisory services for one or several transition economies as well as in order to secure support from more advanced countries of the region for technical assistance, in particular fund-raising, to be provided to economies in transition. These include consultations with governmental officials, representatives of international and sub-regional organizations like EU, OSCE, World Bank, EBRD, UNESCO, SECI, CEI, etc.
- 15. Another observation that should be taken into account in analysing the geographic distribution of regional advisory services missions presented in Table 2 is that in many cases the advisory services provided in a country mentioned in the table concern not only this country but a number of other countries covered by a particular multi-country and/or sub-regional project or activity. For more details on those missions see Annex I.

II. UNECE Technical Cooperation Projects under the General and Local Technical Cooperation Trust Funds, and other sources of funding for operational activities

- 16. A significant part of the UNECE technical cooperation activities are financed from a Portfolio of Extra-budgetary Resources: (a) from contributions to the UNECE General Trust Fund accounts (11) and Local Technical Cooperation Trust Funds (26); and (b) from contributions from UNDP, UNFIP and UNFPA (7). Details on these funds are provided in Annex II.
- 17. It should be noted that in addition to 11 new projects/activities included in the portfolio during 2002, four new projects/activities were included in this portfolio in 2003.
- 18. Depending on the area and goals of specific projects, the implementation activities under these projects/activities were carried out either by regular staff or Regional Advisers, or both. Expenditures under these funds by sub-programme are summarized in Table 3 below.

- 19. As seen from the above table the major part of resources under the UNECE Extrabudgetary Project Portfolio in 2002 was spent on the environment sub-programme (50%) followed by sustainable energy (15%) and transport (11.8%). This reflects the preoccupation of the economies in transition with environmental, energy and transport issues. In 2003, this pattern remained almost unchanged: the first three places were occupied by the same sub-programmes: environment (52.6%), transport (14.1%) and energy (8.4%).
- 20. During 2003 three projects financed from UNDA were implemented, namely: the SPECA project on "Rational and Efficient Use of Energy and Water Resources in Central Asia" (UNECE and UNESCAP; 2001-2003; US\$ 1,750,000); project on "Capacity-building in trade facilitation and electronic business in the Mediterranean" (UNECE, UNESCWA and UNECA; 2002-2003; US\$ 600,000); and project on "Capacity-building in developing interregional land and land-cumsea transport linkages" (UNECE, UNESCAP, UNECLAC, UNECA and UNESCWA; 2002-2006; US\$ 1,250,000). In addition, two new projects that envisage interregional cooperation were developed and submitted for financing from the UNDA, namely: "Capacity-building for air quality management and the application of clean coal combustion technologies in Central Asia" (UNECE, UNESCAP and UNEP; 2004-2006; US\$ 680,000) and "Capacity-building for sustainable utilization, management and protection of internationally shared groundwater in the Mediterranean region" (UNESCWA, UNECA, UNECE, UNESCO and UNDESA; 2004-2006; US\$ 360,000).
- 21. In addition, there were also a number of donor contributions from hosting organizations, national and international donors, and private entities for projects/activities that were managed outside UNECE but where UNECE was involved in their implementation. These include: technical assistance provided by the UNECE Advisory Group on the Protection and Implementation of Intellectual Property Rights for Investment were financed by some private entities (86,200 Euros); seminars/workshops and other activities under the UNECE Water Convention were partly financed by the Czech Republic, Estonia, Finland, Netherlands, Slovakia, Sweden, United Kingdom, UNEP/ROE and EU TACIS Programme; workshops on SMEs were also partly financed by the Konrad Adenauer Foundation (100,000 Euros) and Israel (US\$ 40,000); DESA provided US\$ 21,000 to cover the expenses of some participants from transition economies in the CIS Youth Forum in Ukraine; USAID contributed US\$ 50,000 for the activities of the PPP Alliance; TECHNOBORSA (Italy) financially supported activities under the UNECE-REAG Land for Development Programme.

III. Technical cooperation with sub-regional country groupings

22. Technical cooperation with the Permanent International Secretariat of the **Black Sea Economic Cooperation (BSEC)** is based on the Cooperation Agreement signed in July 2001 and has been developed successfully in the areas of entrepreneurship and SMEs, as well as transport. The focus of cooperation was on facilitating implementation of the 2001 BSEC Declaration on "SMEs at the Dawn of the 21st Century"; and BSEC Transport Action Plan and the Memorandum of Understanding on Facilitation of Road Transport of Goods. In particular, advisory services were provided during BSEC/UNECE/KAF workshops on "Promotion of SMEs – Development of Youth Entrepreneurship" (Republic of Moldova, March 2003); and "How to Develop Information Resources for Entrepreneurs in Internet and Build-up Web sites" (Russian Federation, June 2003). Advisory assistance was provided to the BSEC Working Groups on SMEs and Transport.

Consultations between the two Secretariats were underway on strengthening cooperation in the interrelated areas of transport and trade facilitation, protection of environment and sustainable energy.

- 23. Technical cooperation with the **Central European Initiative** (**CEI**) is based on the Memorandum of Understanding and Cooperation Agreement on Technical Support to the CEI (May 1998) and has been developed in the areas of investment promotion; entrepreneurship and SMEs, including micro-financing; agricultural standards; transport and gender issues. In particular, UNECE technical expertise was made available for the implementation of the WB/CEI project "Micro-financing and advisory services for rural areas in Albania" and the CEI/FAO project on "Wholesale Markets Programme". Advisory services were provided to the CEI Working Groups on SMEs and Transport. In the field of transport, negotiations were underway with the CEI secretariat for a closer cooperation in the implementation of the TEM and TER projects. Finally, advisory assistance was provided during the CEI workshop "Networking for SMEs" (Croatia, September 2003); International Conference "Challenges and Opportunities of EU Enlargement for SMEs in CEI Countries" (Slovenia, November 2003); and the CEI Summit Economic Forum (Warsaw, November 2003) on enterprise development, women entrepreneurship, information society and agricultural standards.
- 24. Technical cooperation with the Inter-State Economic Committee of the Economic Union of the **Commonwealth of Independent States (CIS)** is based on the Memorandum on Interaction signed in April 1997. While a substantial part of the UNECE technical assistance during 2003 was provided to the CIS member countries, cooperation with the CIS bodies was focused on energy issues and entrepreneurship development, in particular under the project on "Energy Efficiency and Energy Security in CIS". Advisory services were provided during the CIS Forum "Youth of the XXI Century: Realities and Perspectives" (Ukraine, September 2003) and subregional workshop on energy efficiency and energy security in CIS (Kyrgyzstan, July 2003) both organized in cooperation with the CIS Executive Committee. Preparations were underway to elaborate a draft CIS Declaration on SMEs at the Dawn of the 21st Century and to develop a project on creating a CIS network of youth entrepreneurship centres.
- 25. Within the UN Special Programme for the Economies of Central Asia (SPECA) advisory services were provided for the implementation of the following projects: "Rational and Efficient Use of Energy and Water Resources in Central Asia"; "Development of Transport Infrastructure and Border Crossing Facilitation"; and "International Economic Conference on Tajikistan in the Regional Context of Central Asia". In particular, under these projects advisory services were provided for the organisation of a Conference in Tajikistan (Dushanbe, April 2003), UNECE Conference on SPECA (Geneva, June 2003), Concluding Conference "International Cooperation Problems of Rational and Efficient Use of Energy and Water Resources in Central Asia" (Bishkek, November 2003) and sessions of the project working groups, workshops, training seminars and courses.
- 26. As far as cooperation within the **SECI/Stability Pact** framework is concerned, advisory services were provided under the SECI "Visa Regime Review" project; SECI/WB-TTFSE Trade Facilitation Programme; UNECE/UNODC/SECI joint project on "Professional Exchange and Training of Law Enforcement Personnel in the SECI/SP Region"; "Development of the Post-clearance Audit Function in the Customs Administrations of the SECI/SP Region"; "Promotion

and Facilitation of a Sustainable Development of the Customs Services in the SECI/SP Region"; SECI/SP "Danube Transport" project; SECI/SP "Transport Infrastructure" project, etc.

IV. Cooperation with other United Nations agencies and regional organizations

- 27. In providing technical assistance to the economies in transition UNECE has continued its cooperation with other organizations of the United Nations family and regional organizations in order to avoid overlapping and duplication of activities, and improve synergy. In this cooperation UNECE relies on both financial resources and technical expertise available in these organizations.
- 28. Within the United Nations family organizations UNDP has been the most prominent partner and funder, in practically all the areas of UNECE technical assistance. Among regional organizations the major partners were the European Commission and OSCE.
- 29. Close relations and cooperation were continued with the United Nations regional commissions, first of all with UNESCAP, in particular on all three SPECA projects. Cooperation with UNESCWA and UNECA continued under the UNDA project on "Capacity-building in trade facilitation and electronic business in the Mediterranean". All five regional commissions cooperated in the implementation of another UNDA project on "Capacity-building in developing interregional land and land-cum-sea transport linkages". During 2003, two new projects that envisage interregional cooperation were developed and submitted for financing from UNDA, namely: "Capacity-building for air quality management and the application of clean coal combustion technologies in Central Asia" (UNECE, UNESCAP and UNEP) and "Capacity-building for sustainable utilization, management and protection of internationally shared groundwater in the Mediterranean region " (UNESCWA, UNECA, UNECE, UNESCO and UNDESA).
- 30. On the whole, cooperation was further developed in the field of: sustainable energy with UNDP, Global Environmental Facility (GEF), UN Foundation/UN Fund for International Partnerships (UNF/UNFIP), European Commission, EBRD; environment and human settlements with UNDP, World Bank, UNEP, UNESCO, European Commission, OSCE, EBRD, EEA; investment promotion WIPO, World Trade Organisation (WTO), OSCE, International Chamber of Commerce (ICC); statistics with UNDP, World Bank, European Commission, Council of Europe, Eurostat, OSCE; trade facilitation –World Bank, UNCTAD, UNIDO, European Commission, World Customs Organization (WCO), WTO, ICC; transport World Bank, European Commission, EBRD, ADB. Occasional cooperation was also maintained with UNDESA and ILO.
