- NOTE 1:This Working Group is of limited membership. It has been established in order to prepare proposals of harmonization of RID/ADR/ADN with the UN Recommendations on the Transport of Dangerous Goods, Model Regulations (see also TRANS/WP.15/AC.1/92, para. 95).
- NOTE 2: The session will take place in room C.3 in the UNECE secretariat building (Palais des Nations, Door No.2, 3rd floor).
- NOTE 3: The session will be held without interpretation, in English. The documentation, including the agenda, is available, or will be made available before the opening of the session, on the website of the UNECE Transport Division, but is not circulated as official UN documentation. Participants are requested to bring their own copies to the meeting.
- NOTE 4: Since all proposals of harmonization will have to be finalized by the end of the meeting, it is not expected that the meeting would end before 28 May, 5.30 p.m.
- NOTE 5: Due to the G8 summit in Evian, France, from 1-3 June, traffic circulation at the border is expected to be problematic. Hotel bookings should be made as soon as possible. As usual, access to the Palais des Nations will be restricted to the bearers of an identity card issued by the Security and Safety Section.
