II. Annotations

1. Adoption of the agenda

In accordance with the Commission's Rules of Procedure, the first item on the provisional agenda is the adoption of the agenda.

2. Election of officers

In accordance with the Commission's Rules of Procedure, the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation, hereafter, the Working Party or SC.3/WP.3, may wish to elect a Chair and, possibly, a Vice-Chair for its forty-fourth and forty-fifth sessions.

3. Results of the fifty-seventh session of the Working Party on Inland Water Transport

The Working Party will be informed of the results of the fifty-seventh session of the Working Party on Inland Water Transport (SC.3), which took place from 16 to 18 October 2013.

The Working Party may wish to take note of the adoption by SC.3 of the mandatory programme of work, biennial evaluation and work plan for 2014–2018 (ECE/TRANS/SC.3/195, paras. 51–56).

The Working Party may also wish to follow-up on the SC.3 decision to start the preparatory work on a high level international conference for the countries with interest in inland navigation (ECE/TRANS/SC.3/195, para. 12). To facilitate the discussion, the secretariat will inform SC.3/WP.3 of the results of relevant discussions with the European Commission, River Commissions, UN regional commissions and other stakeholders. The secretariat will also report on the progress in preparing an overview of the past and planned international events targeting inland waterways, requested by SC.3.

4. Inland waterway infrastructure

(a) European Agreement on Main Inland Waterways of International Importance (AGN)

The Working Party will be informed by the secretariat of the current status of the amendments to AGN and the progress on preparing a third revised edition of the agreement.

The Working Party will also be invited to take note of the decision of the SC.3 fifty-seventh session not to introduce the amendments concerning security to AGN (ECE/TRANS/SC.3/195, para. 13), discussed at the forty-third session of SC.3/WP.3 (ECE/TRANS/SC.3/WP.3/86, para. 9).

(b) Inventory of Main Standards and Parameters of the E Waterway Network ("Blue Book")

The Working Party may wish to note that the amendments to the second revised edition of the Blue Book, approved at its forty-third session (ECE/TRANS/SC.3/WP.3/86, para. 13) were approved by the fifty-seventh session of SC.3 (ECE/TRANS/SC.3/195, para. 19). The amendments are published as an addendum to the Blue Book (ECE/TRANS/SC.3/144/Rev.2/Add.1).

The Working Party will be informed by the secretariat of the new amendment proposals to the Blue Book, if any, as well as of the progress on further expanding the UNECE online database of the E Waterway Network, based on the Blue Book.

(c) Improving the role of inland water transport in secure intermodal transport chains

The Working Party may wish to note that at its fifty-seventh session, SC.3 decided to add in its programme of work for 2014–2018 a new continuing activity under the heading of Inland Water infrastructure, which would consist of supporting initiatives aimed at improving the role of inland water transport in secure intermodal transport chains (ECE/TRANS/SC.3/195, para. 55).

The output expected from this activity, as discussed by SC.3, would entail contributing to a risk assessment of inland waterway infrastructure, on the basis of proposals by UNECE member States and/or River Commissions and contributing to the inclusion of up-to-date data on inland waterways and ports in the relevant agreements on intermodal transport, such as the Protocol on Combined Transport on Inland Waterways to the European Agreement on Important International Combined Transport Lines and Related Installations (AGTC).

The Working Party may wish to discuss the possible joint activities with the UNECE Working Party on Intermodal Transport and Logistics (WP.24), which maintains the AGTC Agreement. In doing so, the Working Party may wish to note that the next annual session of WP.24 is scheduled on 10–11 November 2014, back to back with the next session of SC.3 session (12–14 November 2014).

5. Mutual recognition of boatmasters' certificates and professional requirements in inland navigation

The Working Party may wish to note that at its fifty-seventh session, SC.3 agreed to devote a half-day of the forty-fifth session of SC.3/WP.3 in June 2014 to the first meeting of the International Expert Group on mutual recognition of boatmasters' certificates and harmonization of professional requirements in inland navigation (IEG) and adopted its provisional agenda as set out in ECE/TRANS/SC.3/2013/3 (ECE/TRANS/SC.3/195, paras. 23–26).

The Working Party will be informed by the secretariat of the state of the preparation of the meeting and the inputs necessary from the delegations, if any.

6. European Code for Inland Waterways (CEVNI) (Resolution No. 24, revised)

(a) Work plan for the preparation of the fifth revised edition of CEVNI

The Working Party may wish to note that at its fifty-seventh session, SC.3 included the preparation of the fifth revised edition of CEVNI as one of its two main targets for 2014–2015 (ECE/TRANS/SC.3/195, para. 52).

In this context, the Working Party will be invited to discuss and approve the timeframe and deadlines for preparing and adopting the amendments to CEVNI, based on information on delays to be provided by the secretariat.

(b) Status of amendments to CEVNI

It is recalled that since the adoption of CEVNI 4 by SC.3 on 6 November 2009 and its corrigendum of 13 October 2010 (ECE/TRANS/SC.3/187, para. 23), four sets of amendment have been preliminarily adopted by SC.3. These amendments are to be consolidated in a single amendment package for final adoption as the fifth revised edition of CEVNI.

The consolidated list of the amendment proposals, adopted up to now, is presented in ECE/TRANS/SC.3/WP.3/2014/1, in order to facilitate the delegations' discussion on further amendments to the code.

The Working Party may also wish to note that, since the last session of SC.3/WP.3, the CEVNI Expert Group held three working meetings (its twentieth, twenty-first and twenty-second session, respectively) in order to prepare the amendment proposals to CEVNI, based on the proposal received from Governments, River Commissions and the secretariat. The minutes of the twentieth session, held in in Geneva on 24–26 June 2013, are published in the annex to the report of the SC.3/WP.3 forty-third session (ECE/TRANS/SC.3/WP.3/86). The minutes of the twenty-first session, held on 18–20 September 2013 in Strasbourg, are published in the annex to the report of the SC.3 fifty-seventh session (ECE/TRANS/SC.3/195). The minutes of the twenty-second meeting, held on 17 October 2013 in Geneva, are presented in document ECE/TRANS/SC.3/WP.3/2014/2.

The Working Party will be invited to consider the draft revised Chapter 10, presented in ECE/TRANS/SC.3/WP.3/2014/4, prepared by the secretariat based on the decisions of the CEVNI Expert Group.

7. Recommendations on Harmonized Europe-Wide Technical Requirements for Inland Navigation Vessels (Resolution No. 61, revised)

(a) Status of amendments to Resolution No. 61

The Working Party may wish to note that at its fifty-seventh session, SC.3 approved amendment proposals to the first revised edition of Recommendations on Harmonized Europe-Wide Technical Requirements for Inland Navigation Vessels (Resolution No. 61),

agreed by SC.3/WP.3 at its forty-second and forty-third sessions, and requested the secretariat to include these amendments into the next package of amendments to the resolution (ECE/TRANS/SC.3/195, paras. 35–36).

The consolidated list of the amendment proposals, adopted up to now, is presented in ECE/TRANS/SC.3/WP.3/2014/6, in order to facilitate the delegations' discussion on further amendments to the resolution.

The Working Party may wish to note that SC.3 asked for an additional verification of the amendment to Section 2–7.3 "Data for the identification of a vessel" concerning Maritime Mobile Service Identifiers (MMSI) (ECE/TRANS/SC.3/195, para. 39). SC.3/WP.3 may wish to consider the additional opinions of the delegations on this issue, if any.

The Working Party will be invited to consider the draft amendments and the comments received from the delegations and presented in ECE/TRANS/SC.3/WP.3/2014/7.

SC.3/WP.3 also invited delegations to submit their comments on the proposals contained in ECE/TRANS/SC.3/WP.3/2013/12 to the secretariat (ECE/TRANS/SC.3/WP.3/86, para. 33).

SC.3/WP.3 will be informed of new developments, if any, related to the amendments of chapter 23 and the comments received from the delegations.

8. Establishment of common principles and technical requirements for pan-European River Information Services (RIS)

(a) Guidelines and Recommendations for River Information Services (RIS) (Resolution No. 57)

Following its decision to consider the revision of Resolution No. 57 in 2014–2015 (ECE/TRANS/SC.3/WP.3/86, para. 43), the Working Party may wish to discuss the amendment proposals to the resolution, and, in particular, the proposal of the Russian Federation to complement the resolution with the RIS-related definitions, contained in Informal document SC.3/WP.3 No. 17 (2013).

(b) International standards for Notices to Skippers and for Electronic Ship Reporting in inland Navigation (Resolution No. 60)

The Working Party may wish to note that at its fifty-seventh session SC.3 decided that, since within the EU, the Standards for Notices to Skippers and for Electronic Ship Reporting in Inland Navigation were maintained by two different international expert groups, Resolution No. 60 should be separated into two resolutions. SC. requested the secretariat to prepare draft versions of these resolutions accordingly (ECE/TRANS/SC.3/195, para. 37).

The Working Party may wish to use this opportunity to discuss any further amendments to these standards, which could be introduced in the new resolutions.

(c) International Standard for Tracking and Tracing on Inland Waterways (VTT) (Resolution No. 63)

At its forty-third session, the Working Party considered the draft revised International Vessel Tracking and Tracing (VTT) Standard (Resolution No. 63) prepared by the Chair of the Expert Group on VTT (ECE/TRANS/SC.3/WP.3/2013/14) and the comments received from the Russian Federation and CCNR. SC.3/WP.3 requested the secretariat to ask Governments to provide their comments with a view to possibly further adapting the draft revised Resolution No. 63 accordingly (ECE/TRANS/SC.3/WP.3/86, paras. 37–40).

The Working Party will be invited to consider the comments received from the delegations and the draft revised proposal on the amendment of the Standard (ECE/TRANS/SC.3/WP.3/2014/10).

9. Recreational navigation

(a) Status of Resolution No. 40

The Working Party may wish to note that at its fifty-seventh session, SC.3 adopted the third revised edition of Resolution No. 40. In doing so, SC.3 reaffirmed that the International Certificate (international card) for Pleasure Craft (Resolution No. 14) had been superseded by Resolution No. 40. Acknowledging that several member States still apply Resolution No. 14 or apply simultaneously both resolutions, SC.3 requested the secretariat to contact Governments to encourage them to apply only Resolution No. 40 (ECE/TRANS/SC.3/195, para. 45).

In this context, SC.3/WP.3 will be informed by the secretariat on the publication of third revision edition of Resolution 40 and the first results of the exchange with the member States on the use of Resolution No. 14, as well as on any new development with respect to the implementation of the resolution.

(b) Draft Guidelines to Resolution No. 40

At its forty-third session, SC.3/WP.3 considered the draft guidelines on the application of Resolution No. 40, prepared by the European Boating Association, and invited delegations to provide their comments on the proposed text (ECE/TRANS/SC.3/WP.3/86, para. 48). The comments received from the Governments and the updated draft guidelines are contained in ECE/TRANS/SC.3/WP.3/2014/11.

The Working Party may wish to finalize the text of the guidelines and transmit it to SC.3 for approval at its fifty-eighth session. In doing so, SC.3/WP.3 may wish to discuss the most appropriate solution for including in the guidelines the reference to the list of the countries who have accepted the resolution and the competent national authorities can be found, currently contained in Annex IV of Resolution No.40.

10. Other business

(a) Diesel engine exhausts

In its questionnaire circulated for the forty-third session, the secretariat had invited UNECE member States to advise on the current application of the provisions of chapter 8a of the annex to Resolution No. 61, revised, "Exhaust and Pollutant Particulate Emissions from Diesel Engines". Inputs received from the delegations were collected by the secretariat in order to prepare a discussion paper on diesel engine exhausts. The Working Party may wish to take note of the final paper on this issue, presented in Informal document No. 1.

(b) Theme topic for the next SC.3 session

The Working Party may wish to discuss the modalities of the preparation of this policy discussion. In doing so, it may wish to consider how these preparations can be combined with and build upon the planned first session of the first meeting of the IEG, planned for June 2014.
