1. Adoption of the agenda

In accordance with the Commission's Rules of Procedure, the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation, hereafter, the Working Party or SC.3/WP.3, may wish to elect a Chair and, possibly, a Vice-Chair for its forty-eighth and forty-ninth sessions.

3. Outcome of the fifty-ninth session of the Working Party on Inland Water Transport

The Working Party will be informed about the main decisions taken by the Working Party on Inland Water Transport (SC.3) at its fifty-ninth session, which took place from 9 to 11 November 2015.

4. Workshop on inland water transport security

The Working Party will be informed that SC.3 at its fifty-ninth session agreed to organize an inland navigation security workshop in conjunction with the forty-eighth session of SC.3/WP.3 according to the proposal of the Sustainable Transport Division and asked the secretariat to make the necessary preparations. This future event will provide an overview of how inland navigation safety and security issues are addressed in member States and also look into: what security-related competences and skills are currently required by national regulators and how crews are trained; and national experiences in organizing safety and security management systems for ports, ships and freight, etc.

The Working Party is invited to share best practices in this field and to take part in discussions on major safety and security (and their interrelationship) issues in inland navigation.

5. Follow-up to the UNECE White Paper on efficient and sustainable inland water transport in Europe: Discussion of a new strategy proposal

The Working Party will be informed about the revision of the strategy of SC.3 as decided at its fifty-ninth session (ECE/TRANS/SC.3/201, para.16). The Working Party may wish to consider the comments, submitted to the secretariat, on the first draft of a new strategy proposal for SC.3 and to discuss is second proposal which was drafted on the basis of the first.

The Working Party may also wish to discuss a progress report on the revision of the strategy prepared by the secretariat for the seventy-eighth session of the Inland Transport Committee (hereafter ITC) which will be held on 23–25 February 2016.

6. Inland waterway infrastructure

(a) European Agreement on Main Inland Waterways of International Importance (AGN)

The Working Party will be informed by the secretariat about the current status of the AGN. The Working Party will be further informed about the decision taken by the Working Party on Intermodal Transport and Logistics (WP.24) at its fifty-eighth session on the proposal related to the alignment of the Protocol on Combined Transport on Inland Waterways to the AGTC Agreement with the European Agreement on Main Inland Waterways of International Importance (AGN). SC.3/WP.3 may wish to discuss further actions aimed at aligning these two documents as well as further cooperation with WP.24.

(c) Inventory of Most Important Bottlenecks and Missing Links in the E Waterway Network (Resolution No. 49, revised)

The Working Party may wish to discuss further progress in infrastructure projects aimed at elimination of bottlenecks and missing links in the E Waterway Network in the light of a revision of the Blue Book. The Working Party may wish to consider revising the list of most important bottlenecks and missing links, as set out in the annex of Resolution No. 49, revised, on the basis of available information.

(d) Guidelines for Waterway Signs and Marking (Resolution No. 59, revised)

SC.3 at its fifty-ninth session had asked the secretariat to prepare a proposal on the basis of the "Instruction on the Mode of Installation of Waterway Signs and Marking on the Danube" (ECE/TRANS/SC.3/2015/5) submitted by the Danube Commission and the fifth edition of the European Code for Inland Waterways (CEVNI). The Working Party may wish to consider the document prepared by the secretariat (ECE/TRANS/SC.3/WP.3/2016/3).

7. Mutual recognition of boatmasters' certificates and professional requirements in inland navigation: Sixth meeting of the International Expert Group

The Working Party may wish to note that SC.3 at its fifty-ninth session agreed to devote a half-day of the forty-eighth session of SC.3/WP.3 to the sixth meeting of the International Expert Group on Mutual Recognition of Boatmasters' Certificates and Harmonization of Professional Requirements in Inland Navigation (IEG). The Working Party may wish to also note that SC.3 had suggested that the provisional agenda of the third IEG meeting be the same as the agenda of the fifth meeting:

1. Exchange of information on boatmasters' certificates in inland navigation and professional requirements in inland navigation in the UNECE region.

IEG may wish to continue the exchange of information on this matter on the basis of ECE/TRANS/SC.3/WP.3/2015/1, ECE/TRANS/SC.3/WP.3/2015/2, Informal documents SC.3/WP.3 Nos. 14 and 15 (2015).

2. Proposal on means and measures to make the professions of boatmaster and other crew members employed in inland navigation more attractive and to bring these professions into line with modern requirements.

IEG may wish to exchange information on education and professional knowledge requirements of crew members of vessels using liquefied natural gas (LNG) for propulsion, on navigation training simulators and local knowledge requirements. This information may become an update to the annex of Resolution No. 31.

3. Analysis of existing national, regional and international instruments relating to the mutual recognition and modernization of professional qualifications in inland navigation.

IEG is invited to continue discussion on a new document prepared by the secretariat on the basis of ECE/TRANS/SC.3/WP.3/2015/2 and the proposal of the Group of Volunteer Experts on Resolution No. 61 for revising Chapter 23 of Resolution No. 61 (ECE/TRANS/SC.3/2015/6).

4. Local knowledge requirements: drawing up criteria to help determine the conditions where local knowledge requirements could be necessary.

IEG may wish to continue discussion on updating the list of local knowledge requirements existing in the ECE region (ECE/TRANS/SC.3/2010/12 and Corr.1).

5. Discussion on establishing the procedures of expert training and examination within the ECE region, on the basis of the synthesis of the information submitted by UNECE member States (ECE/TRANS/SC.3/2014/15) (Standards of Training and Certification for personnel in Inland Navigation (STCIN)) and consolidated by PLATINA (ECE/TRANS/SC.3/2014/16 and Corr.1).

IEG may wish to discuss comments from the member States on STCIN as consolidated by PLATINA (ECE/TRANS/SC.3/2014/16 and Corr.1), if any.

8. Standardization of technical and safety requirements in inland navigation

(a) European Code for Inland Waterways (CEVNI) (Resolution No. 24, revised)

The Working Party will be informed about the proposals for further amendments of CEVNI submitted so far (ECE/TRANS/SC.3/WP.3/2016/5). The Working Party may wish to discuss the dates of the next meeting of the CEVNI Expert Group, depending on the number of amendment proposals, as decided by SC.3 at its fifty-eighth session.

The Working Party may also wish to begin discussion on the update of the CEVNI Status document and on information submitted to the questionnaire on regional and national special requirements, as approved by SC.3 at its fifty-eighth session.

The Working Party will be informed about the current situation with the translation of CEVNI into German and the availability of the text of CEVNI in other languages of member States as discussed at the fifty-ninth session of SC.3.

10. Harmonization of the pan-European legal framework for inland navigation: The International Convention on Registration of Inland Navigation Vessels

The Working Party will be invited to continue discussion on possible updating of the International Convention on Registration of Inland Navigation Vessels and how to facilitate its efficiency on the basis of document ECE/TRANS/SC.3/2015/15. The secretariat will inform the Working Party about reactions received from Contracting Parties to the Convention and comments of River Commissions on possible modification of Article 3 of the Convention which could cause implications for their regulatory frameworks.
