EXPLANATORY NOTES

1. ADOPTION OF THE AGENDA

In accordance with the Commission's Rules of Procedure, the first item on the provisional agenda is the adoption of the agenda (TRANS/WP.11/205).

2. ELECTION OF OFFICERS

At its last session, the Working Party elected Mr. M. Eilsoe (Denmark) and Mr. B. McGregor (United States of America), Chairman and Vice-chairman, respectively, for the fifty-eighth session.

3. ACTIVITIES OF ECE BODIES OF INTEREST TO THE WORKING PARTY

(a) <u>Inland Transport Committee</u>

At its sixty-fourth session (18-21 February 2002), the Inland Transport Committee adopted the report of the Working Party on its fifty-seventh session.

The Committee adopted two resolutions: resolution No. 249 on safety in tunnels and Resolution No.250 on promotion of inland water transport (ECE/TRANS/139, annexes 1 and 2).

Concerning the questions related to transport and security after the tragic events of 11 September 2001, the Committee **requested** its subsidiary bodies to identify, within their respective fields of competence, the differences between "security" and "safety" concepts and the relevant concrete questions that could be addressed in this respect, taking into account the work and studies undertaken by other organs, in particular by ECMT (ECE/TRANS/139, paras. 18 and 19)

(b) <u>Working Party on Standardization of Perishable Produce and Quality Development (WP.7)</u>

The Working Party will be informed about the activities of the Working Party on Standardization of Perishable Produce and Quality Development (WP.7).

4. ACTIVITIES OF THE OTHER INTERNATIONAL ORGANIZATIONS OF INTEREST TO THE WORKING PARTY

(a) <u>International Institute of Refrigeration (IIR)</u>

The Working Party will be informed about the major results of the ATP Test Stations Meeting held in Hamburg (Germany), 6-7 June 2002.

(b) <u>Transfrigoroute International</u>

The Working Party will be informed of recent activities of Transfrigoroute International.

5. IMPLEMENTATION OF THE AGREEMENT ON THE INTERNATIONAL CARRIAGE OF PERISHABLE FOODSTUFFS AND ON THE SPECIAL EQUIPMENT TO BE USED FOR SUCH CARRIAGE (ATP)

(a) <u>Information on the status of application of the Agreement</u>

To date the following States have become Parties to the Agreement: Austria; Azerbaijan; Belarus; Belgium; Bosnia and Herzegovina; Bulgaria; Croatia; Czech Republic; Denmark; Estonia; Finland; France; Georgia; Germany; Greece; Hungary; Ireland; Italy; Kazakhstan; Lithuania; Luxembourg; Monaco, Morocco; Netherlands; Norway; Poland; Portugal; Romania; Russian Federation; Slovakia; Slovenia, Spain; Sweden; The former Yugoslav Republic of Macedonia; United Kingdom; United States of America; Uzbekistan; Yugoslavia.

Switzerland signed the Agreement without ratification.

(b) <u>Test stations officially designated by the competent authorities of countries Parties to ATP</u> and whose test reports might be used for the issue of the ATP certificates

The Working Party may wish to invite the Governments of Contracting Parties to transmit additional information concerning the competent authorities issuing certificates of conformity, the officially recognized testing stations and the addresses of bodies to contact in the event of any problems with a view to updating document TRANS/WP.11/2002/1.

(c) Exchange of information among Parties under Article 6 of ATP

The Working Party will be informed about any information transmitted by the Contracting Parties under Article 6 of ATP.

6. AMENDMENTS TO THE AGREEMENT ON THE INTERNATIONAL CARRIAGE OF PERISHABLE FOODSTUFFS AND ON THE SPECIAL EQUIPMENT TO BE USED FOR SUCH CARRIAGE (ATP) WHICH HAVE ENTERED INTO FORCE

The Working Party will be informed of the amendments to ATP which have entered into force since the last session.

The Working Party may wish to note that:

- the proposal of amendments to Appendix 1, Annex 1 to ATP adopted during the last session (TRANS/WP.11/204, paras. 26 and 27, and annex 2) was circulated by the Depositary (see C.N.106.2002.TREATIES-1).

(e) <u>Annex 3 to ATP</u>

Temperature conditions for the carriage of certain foodstuffs which are neither quick (deep)-frozen nor frozen

France submitted an official objection to the entry into force of this Annex. considering that the adoption of this amendment seemed premature in view of the revision of similar texts within the European Union (TRANS/WP.11/204, para. 45).

8. PROCEDURES FOR THE APPROVAL OF MULTI-COMPARTMENT MULTI-TEMPERATURE VEHICLES

Following the Hamburg meeting, the Working Party may wish to consider the procedures for the approval of multi-compartment multi-temperature vehicles (TRANS/WP.11/204, paras. 46-49).

9. REVISION OF THE ANNEXES TO ATP

The Working Party may wish to consider a proposal of the new version of the revised Annexes (TRANS/WP.11/2002/12).

This version includes the models of Test reports in the French proposal (TRANS/WP.11/2001/4).

10. ATP HANDBOOK

The Working Party may wish to consider the report of the Informal Group held in Cambridge (United Kingdom), 22-24 April 2002 (TRANS/WP.11/2002/10) and proposals submitted by France (TRANS/WP.11/2000/10 and TRANS/WP.11/2001/4).
