#### **Third UNECE Forum of Women Entrepreneurs “Building partnerships to close the entrepreneurship gender gaps in the UNECE region”**

Baku, 14 - 15 November 2012

### **Information notice**

#### **Note by the secretariat**

#### **I. Introduction**

1. The Beijing Platform for Action adopted at the Fourth World Conference on Women in Beijing (1995) highlighted the importance of promoting women’s economic rights and independence. It called on governments to ensure equal access to and control over economic resources for women and men and encouraged the provision of business services, training and access to information and communication technologies. The fifteen-year review of the implementation of the Beijing Platform for Action by the United Nations Economic Commission for Europe (UNECE) undertaken in 2009 highlighted important gender gaps in the economic realm. The Chairperson’s Conclusions at the Beijing +15 Regional Review Meeting organized on 2-3 November 2009 in Geneva therefore called for further efforts to strengthen women’s opportunities to get involved in economic activities, including through entrepreneurship. In accordance with this request and after consultations with the authorities and other stakeholders in Azerbaijan, it was agreed to hold the Third UNECE Forum of Women Entrepreneurs on 14 and 15 November in Baku, Azerbaijan.

2. This Information notice provides details regarding the organization of and participation in the above-mentioned Forum, which will jointly be organized by the Economic Cooperation and Integration Division and the Gender and Economy Programme at the UNECE in cooperation with the State Committee for Family, Women and Children Affairs of the Republic of Azerbaijan.

3. UNECE has a longstanding commitment to the promotion of women’s entrepreneurship development. Respecting this commitment, over the past decade the UNECE has been active in promoting the potential of women entrepreneurs in the region. The UNECE’s convening power allows this organization to directly address decision makers of its Member States to raise awareness on issues related to women’s entrepreneurship. In this spirit, in 2001 and 2003 UNECE organized two fora bringing together women entrepreneurs and government representatives from the whole UNECE

region (which includes the countries from South-East Europe, Central Asia, Central and Eastern Europe as well as Western Europe and North America). These events discussed key issues of concern and identified good practices in gender-sensitive entrepreneurship policies.

4. In 2010, a subregional Forum, namely the First Forum of South East European Women Entrepreneurs, took place in Istanbul. It focused on assisting those women entrepreneurs in South-East Europe who intended to expand their activities or render them more innovative. In September 2011, UNECE organized a policy seminar on women's entrepreneurship development in Central Asia. This seminar discussed the major findings of the assessments of the business environment for women entrepreneurs in Tajikistan and Kazakhstan.

5. The Third Forum will continue the UNECE tradition of integrating women entrepreneurs and women's business associations within the region, strengthening their networks and building partnerships with government and research institutions, non-governmental organizations (NGOs) and international organizations.

## **II. Objectives and scope**

6. The main objective of the Third UNECE Forum of Women Entrepreneurs is to provide a platform for a broad exchange of practical experiences and lessons learned among policymakers, business community (female and male entrepreneurs) and academia, as well as other stakeholders on good practices and policies of promoting women's entrepreneurship development and narrowing the gap between the scopes of women's and men's entrepreneurial activities in the UNECE region.

7. The Forum will address issues in the following key areas:

- Promoting women's entrepreneurship through policies, strategies and programmes;
- Strengthening networks among women entrepreneurs at national, regional and global levels;
- Financing women entrepreneurs;
- Innovative entrepreneurship and gender sensitive policies; and
- Developing women entrepreneurship in rural areas.

8. The programme of the Forum includes three thematic sessions which will cover different challenges to women entrepreneurship at regional and country levels, as well as problems faced by innovation-based enterprises. With a view to ensuring broad possibilities of exchange of information, learning and networking each session will include presentations by both leading international and national experts. Major issues to be covered are presented in the Annotated Provisional Programme (Annex I).

## **III. Organization**

9. The Third UNECE Forum of Women Entrepreneurs will take place on 14 and 15 November 2012 in Baku, Azerbaijan.

10. The registration of participants for the Forum will start on 14 November at 8.30. The Forum will begin at 9.30 on the same day and finish on 15 November at 13.00. It will be organized into three working sessions and a closing session which will come up with the conclusions of the Forum in the form of a Declaration.

## **IV. Participation**

11. Participation is open to interested parties from UNECE member countries and other Member States of the United Nations, representatives of United Nations specialized agencies and international organizations participating in the activities of UNECE. Broad participation of government officials, the private sector, including women entrepreneurs and the women entrepreneurship associations, as well as academia is welcome.

12. To ensure participation of national experts with relevant expertise, Governments are invited to inform on the Forum national entities dealing with the issues to be discussed at this event, including SME, as well as women's and industry associations, consulting companies and other stakeholders.

## **V. Conference fee**

13. No conference fee is charged for participation in the Forum. Travel and accommodation expenses are expected to be borne by the participants.

## **VI. Passports and visas**

14. All participants should be in possession of a valid passport, with an entry visa (if required) which can be obtained from the diplomatic representation of Azerbaijan in their country of residence. It is advisable to make such visa applications well in advance of the date required.

## **VII. Preliminary registration**

## **VIII. Documentation**

16. UNECE Member States, intergovernmental and non-governmental organizations, companies and individual experts and entrepreneurs are invited to prepare papers for presentation at the Forum. Main issues to be covered by such papers are presented in the Annotated Provisional Programme (Annex I).

17. By 15 October 2012, the secretariat should receive papers for presentation in English, French or Russian. The secretariat encourages submission of papers in electronic format, preferably by e-mail. Papers will be circulated in the language of submission. The updated Provisional programme of the Forum will be circulated to the registered participants about one week before this event.

## **IX. Interpretation and visual aids**

18. Simultaneous interpretation in English and Russian, facilities for projecting slides, as well as facilities for computer-aided presentations (e.g. Power Point) will be provided.

**15.00 - 18.00 SESSION 2. GENDER ASPECTS OF INNOVATION-BASED ENTREPRENEURSHIP**

This session will consider drivers of innovative entrepreneurship and difficulties that entrepreneurs face when establishing an enterprise based on R&D results (including gender specific hindrances such as differences in education patterns of men and women, lack of entrepreneurial training tailored to women's needs, difficulties of attracting external finance by female entrepreneurs, etc.). It will discuss the bottlenecks to innovation-based entrepreneurship (e.g. inadequate regulatory framework and lack of government assistance to innovative companies) and the corrective action required from governments and other stakeholders aimed at improving the regulatory and institutional environment to promote

innovation-based enterprises, including those operated by women. Finally, the session will address the issues of developing the cooperation between governments and other stakeholders (private sector, academic and educational institutions) to facilitate innovative entrepreneurship by men and women.
