Report on capacity-building activities¹

I. Introduction

1. The terms of reference of the Committee on Innovation, Competitiveness and Public-Private Partnerships (CICPPP) stress the importance of demand-driven policy advisory services and other capacity-building activities in its mandated areas of work.

2. At its eighth session, held from 12 to 14 February 2014, the Committee welcomed the positive results of capacity-building activities, in particular, from field-based events, organized upon the request of member States. It also thanked the donors who had made voluntary contributions, and emphasized the importance of these financial and in-kind contributions for the success of the policy advisory services and capacity building activities as well as for extending the outreach of such activities.

3. This document reports capacity-building activities carried out by the Economic Cooperation and Integration subprogramme from 1 January 2014 till 30 June 2015. These activities were funded through the regular budget of the Economic Cooperation and Integration subprogramme and through extra-budgetary resources raised by the Economic Cooperation and Trade Division. It also includes activities undertaken or coordinated by the Regional Advisor of the Economic Cooperation and Integration subprogramme.

4. During the reporting period, the secretariat benefited from voluntary contributions (including in-kind contributions) from the Government of Israel, the Government of the Netherlands, the Government of the Russian Federation, the Eurasian Development Bank, the European Union, the Bank for Development and Foreign Economic Affairs (Vnesheconombank) of the Russian Federation, and Toyo University, Japan.

5. The document includes capacity-building activities where the secretariat took the lead in organizing the activity, taking responsibility for the major part of the substantive, logistical and financial arrangements and where the secretariat staff participated as co-organizers and/or contributed to the substantive part of an event. In all of these activities, the secretariat mobilized substantive support from its extensive networks of experts.

6. In order to extend the outreach of policy recommendations, the secretariat strives to design Geneva-based meetings in such a manner that they include capacity-building components for participating member States.

7. The document is structured as follows. The second section describes some highlights from the capacity-building activities during the reporting period. Section III discusses plans for capacity-building and policy advisory activities in the near future. Annex I presents a table with a complete list of all capacity-building activities which were carried out by the Economic Cooperation and Integration subprogramme during the reporting period. It lists information on the objectives, results, total expenditures, sources of funding and partners for each activity.

II. Major results in capacity-building activities in the reporting period

8. In the area of Innovation and knowledge-based development, the secretariat conducted an Innovation Performance Review together with the Government of Tajikistan and worked with the Governments of Armenia, Belarus and Kazakhstan on the implementation of policy recommendations that were made in the respective Innovation Performance Reviews of these countries.

9. The secretariat supported science, technology and innovation policy development of the member countries of UN Special Programme for the Economy of Central Asia (SPECA), organizing two high-level meetings for the Project Working Group on Knowledge-based Development with capacity-building components.

10. The Team of Specialists on Innovation and Competitiveness Policies developed new policy recommendations on smart specialization and facilitated the networking and cooperation among the member States. The secretariat also contributed to the capacity-building of member States, in sharing lessons learnt and by providing advices at seminars and events organized by the partner organisations.

11. In the field of Public-Private Partnerships (PPP), the programme International PPP Centre of Excellence has carried out capacity building and advisory missions along four main kind of activities: (i) consultative missions of the UNECE PPP Business Advisory Board with national authorities on national PPP policies, programmes and projects; (ii) a PPP capacity building project in Belarus; (iii) Master classes and trainings on PPPs; (iv) international fora and conferences for the exchange of PPP best practices and models.

12. These PPP related capacity building activities contributed to the better understanding on the need of enabling environment (policies and institutions); to improve PPP projects development and delivery; to enhance the ability of national officials to develop and implement successful PPP projects; to identify international PPP best practices and models in different sectors and to agree and understand the UNECE process for the development of international PPP standards for the Sustainable Development Goals (SDGs).

III. The way forward

13. The demand from countries with economies in transition for the Committee's capacity-building and policy advisory activities is growing, in particular for activities that have a national focus. The secretariat will continue to respond to this growing demand within available resources and mandates.

14. The Sustainable Development Goals (SDGs), which are expected to be adopted by the UN General Assembly in September 2015, will commit all member States, including those of the UNECE region, to take active measures to reconcile economic development with environmental sustainability and social inclusion over the coming 15 years.

15. Achieving the SDGs will require massive investments in infrastructure; therefore public-private partnerships have the potential to play a key role in mobilizing the necessary financial resources, while harnessing private sector expertise to deliver optimal value for money. It will also require innovation and international cooperation to ensure that innovative solutions to sustainable development challenges are not only developed but also deployed rapidly and at the necessary scale everywhere. The capacity-building and policy advisory activities of the Committee on Innovation, Competitiveness and Public-private Partnerships are expected to contribute to UNECE's work on advancing the SDGs at the regional level.

16. Taking into account the valuable experiences gained and the relative strengths of each organization, the secretariat will continue to carry out its capacity-building activities in close cooperation with other international organizations in areas of common interest with a view to assuring complementarities and synergies.

17. The secretariat will continue to invite member countries, and members of the teams of specialists to actively contribute to capacity-building activities and other technical-cooperation activities.
