The Working Party on Public-Private Partnerships is an intergovernmental body established in 2016 to take over the UNECE PPP work previously conducted by the Team of Specialists on Public-Private Partnerships. It comprises over 2000 experts coming from the public and private sector, NGOs and international organizations. On 21-22 November 2017, the session will focus on the contribution of the UNECE work on people-first Public-Private Partnerships to the United Nations Sustainable Development Goals (SDGs), with an opportunity for countries to present their current people-first PPP work. The advanced work on the draft guiding principles on people-first PPPs and the international PPP standards will be debated, along with the role of national development agencies in support of infrastructure projects in low and middle-income countries and the creation of an evaluation methodology to score PPPs and infrastructure projects against the SDGs.

Representatives from PPP Units and infrastructure agencies will prepare short presentations on their strategies and projects and how these contribute to the UN SDGs. These presentations will be made available to participants in a compendium. The three sets of panellists in this Session will address the following questions:

- i. How can we improve PPP to make it a more ‘fit for purpose’ vehicle for the UN development agenda?
- ii. Where and how do you see changes in the way PPP is done in your country that gives ground for optimism?
- iii. Do the UN SDGs need the PPP units to give their collective voice in support? How can practically this support be expressed?
- iv. What do countries need from national aid agencies to make people first projects a reality?
- v. Can you give examples of projects – either at the planning state or operational – which can demonstrate people first PPPs?
- vi. One of the new trends is the launching of “regional masterplans”, that is, regional infrastructure programmes that are cross border in nature and are being rolled out as prospective PPP initiatives. How can countries cooperate better in these programmes? What is the role for organisations such as the UNECE to harmonise practices, institutions etc. that can facilitate these regional masterplans?
