The Working Party on Public-Private Partnerships is an intergovernmental body established in 2016 and it comprises over 2000 experts coming from the public and private sector, NGOs and international organizations. On 3-4 December 2019, the session will focus on the contribution of the UNECE work on People-first PPPs to the United Nations Sustainable Development Goals (SDGs), with a policy discussion addressing a number of key challenges, including the pros and cons of a People-first Project Facilitation Hub to assist Governments to identify and prepare the right projects that comply with the SDGs. The ongoing work on the Project Impact Assessment Tool as a mechanism to evaluate and score projects in compliance with the SDGs and case studies will also be presented.

10:45–13:00 Session I: Identifying People-first pilot projects for low and middle-income countries

Challenge

The challenge is that Governments have difficulties in identifying priorities in projects in order to meet the Sustainable Development Goals (SDGs). In parallel there are often weak enabling environments existing in many low and middle-income countries – indeed in precisely the countries most in need of high-quality ‘People-first’ PPPs.

Key questions

Project pipeline:

- (i) What are the projects that can best be described as People-first?
- (ii) Are there sectors where People-first PPPs cannot be achieved and should thus be avoided?

Project Evaluation Tool:

- (i) How would the evaluation methodology currently being developed by UNECE work to screen projects?

Policies and Enabling environment for People-first PPPs:

- (i) Rather than doing everything that is required, are there priority actions that countries should do in developing a People-first enabling environment?
- (ii) Transparency and accountability issues are prevalent in many low and middle-income countries: how should governments best implement the UNECE [standard](#) and [declaration](#) on a Zero Tolerance Approach to Corruption in PPP procurement?
- (iii) How should Governments deal with the challenge of ‘unsolicited bids’?

15:00–16:30 **Session II: How will a Project Facilitation Hub help to develop these projects?**

Background

The proposed Hub would consist of both a Fund and a Facilitating entity. The Fund would be hosted at a Multilateral Development Bank (MDB). The facilitating entity would be located in a place to be determined. The Hub would advance People-first PPP models for the SDGs. Donors (typically governments or supranational entities such as the EU) will contribute to the fund in order to support its purpose, namely financing People-first PPPs.

Challenge

Getting this Fund and the Facilitation entity up and running constitutes a considerable challenge, especially if the Hub is to have the impact required. Beyond these considerable logistical challenges, the Hub needs to address the following:

- People-first PPPs might be more costly to undertake than traditional PPPs;
- Civil society and local communities should be involved in actual delivery as far as possible but the mechanisms for doing this are not always apparent;
- There is in addition strong reluctance by companies to invest in high-risk low-income countries. Thus, a priority for the work of the Hub would be to work to mitigate the risks for investors establishing PPP arrangements in such countries.

Key questions:

- (i) How could the Hub screen countries that are not able to meet People-first standards and best practices and benefit from its services?
- (ii) How could the Hub develop capacities by working with governments to deliver projects?
- (iii) How does the Hub lower the risk in order to implement and make affordable People-first PPP projects?

Challenge

Conscious of the need to accelerate the development of a necessary high-quality project pipeline as well as a new type of more inclusive projects where all stakeholders – civil society, governments themselves and the private sector – have a key role to play in projects and by definition in the operations of the Hub itself, the challenge is to develop the Hub in a way in which it can be inclusive where each participant’s contribution is welcomed as part of a level playing field and no conflict of interest ensuring transparency effectiveness and good governance.

- Should it be a fund located in an MDB or should it be just a facilitating entity?
- How can the various entities and stakeholders work under the auspices of the Hub?
- Where would the financing come from?
- What should be the role of the UNECE in the Hub’s operation?
