### **Item 1: Adoption of the Agenda**

Opening, adoption of the agenda and remarks by the Chair and the Executive Secretary.

### **Item 2: UNECE Reform – the way forward:**

- (a) Adoption of the Terms of Reference and Rules of Procedure of the Executive Committee and Adoption of Revised Terms of Reference and Rules of Procedure of the Commission;
- (b) Implementation of the Reform;
- (c) Linkages between the UNECE Reform and the Global United Nations Reform;
- (d) Organizational changes in the secretariat.

Under sub-item (a) it is proposed that the Commission adopt the Terms of Reference and Rules of Procedure for the Executive Committee as called for in the Work Plan on UNECE Reform adopted by member States on 2 December 2005. It is also proposed that the Commission adopt revised Terms of Reference and Rules of Procedure for the Commission.

Under sub-item (b) the Commission will discuss, with the participation of the Chairs of the Sectoral Committees, the implementation of the Work Plan on Reform, including cooperation with partner organizations. With regard to the latter, the Commission will, with the active participation of partner organizations, discuss how such cooperation can be strengthened or re-launched as necessary. Chairs of the Sectoral Committees will also be invited to report on the upcoming challenges confronting their Committees as well as to highlight major achievements.

Under sub-item (c), information will be provided regarding the global UN reform and its linkages with UNECE reform.

Under sub-item (d), the secretariat would be invited to update the Commission on the implementation of the reform within the secretariat.

### **Item 3: The economic context for UNECE Reform: challenges, policy responses and the role of the UNECE**

The Work Plan on UNECE Reform states that the UNECE facilitates greater economic integration and cooperation among its fifty-five member States and promotes sustainable development and economic prosperity through its various activities.

In line with the above, debate under this item will focus on how member States view the challenges to achieving sustained growth and how they see the UNECE, in cooperation with

other relevant organizations, supporting member States' economic policies. In particular, the debate should aim to identify specific areas of policy where UNECE can contribute along the main directions established by the Reform

This item will be supported by a synthesis of the UNECE publication on the achievement of the Millennium Development Goals in the UNECE Region and a conference room paper.

## **GENERAL SEGMENT**

### **Item 4: Preparation of the Strategic Framework for 2008-2009**

As indicated in document A/60/430 on the implementation of decisions from the 2005 World Summit Outcome for action by the Secretary-General, the preparation of the proposed strategic framework for 2008-2009 for the Organization will be initiated by the Secretary-General subsequent to the General Assembly's review of all mandates older than five years. The proposed strategic framework for the Organization as a whole will then be submitted to the Committee for Programme and Coordination in August/September 2006 so that its recommendations may be presented to the Assembly at its sixty-first session. The anticipated deadline for the submission of UNECE's proposed strategic framework to the Secretary-General is end-March 2006.

In line with the above, the Commission is invited to review and comment on the UNECE draft strategic framework, in compliance with the programme planning process adopted by the Commission at its Annual Session in February 2005. In this connection it is recalled that the first draft of UNECE's strategic framework (Biennial Programme Plan) for a given biennium is to be prepared by the secretariat, revised as appropriate on the basis of comments received from the Sectoral Committees in respect of their respective sub-programmes and then submitted to the Group of Experts on the Programme of Work for review and comments. Thereafter, as indicated above, the Commission reviews and comments the draft.

Under this item, the Chair of the Group of Experts will also provide information concerning the work of the Group of Experts since the sixtieth session.

### **Item 5: Technical cooperation activities of the UNECE**

Discussion under this item will be supported by a background document that provides information on the technical cooperation activities undertaken by the UNECE during the inter-sessional period, including joint projects carried out with other organizations.

The document will also update the Commission on efforts taken to have the UNECE included on the OECD's "DAC list of Main International Organizations" since only contributions to the Organizations contained on this list are reportable as the Official Development Assistance (ODA) or the Official Assistance (OA).

**Item 6: Progress report on specific issues**

(a) UNECE contribution to CSD cycles

The Second UNECE Regional Implementation Meeting on Sustainable Development was held on 15-16 December 2005. The outcome was a Chairman's Summary that focused on particular obstacles encountered and major breakthroughs made in the implementation of partnerships, actions and measures related to the priority clusters (Energy for Sustainable Development, Industrial Development, Air Pollution/Atmosphere and Climate Change) and cross-cutting issues. The inclusion of this item will permit member States to reflect on the Meeting and extract lessons learned, as well as to be updated on preparations for the upcoming April 2006 session of the Commission on Sustainable Development.

(b) Promotion of ICT in UNECE work

At its sixtieth session, the Commission agreed that the UNECE should promote the use of ICT in the UNECE work programme with the aim of increasing its efficiency and efficacy on a demand-driven basis. The Commission encouraged Principal Subsidiary Bodies to further strengthen their efforts to develop and use appropriate e-applications in a cost-efficient manner and agreed to evaluate progress that had been made at the sixty-first Annual Session.
