1. In accordance with the Commission's rules of procedure, the first item on the provisional agenda is the adoption of the agenda. ### Item 2: Election of officers

2. The Committee will be invited to elect a Bureau or confirm/ re-elect the existing Bureau.

### Item 3: Securing Sustainable Energy Supply: Time to Act

3. The twenty-second session of the Committee on Sustainable Energy will focus its dialogue on the functions that the UNECE and the Committee must fill to serve member States in their efforts to Securing Sustainable Energy Supply in line with the "Sustainable Energy for All" initiative of the Secretary-General.

4. The session will focus, in particular on five high-level themes:

- (a) Achieving Sustainable Energy for All (SE4All) in the UNECE Region;
- (b) Reliable and Stable Transit of Energy Resources and Its Role in Ensuring Sustainable Development and International Cooperation: Contribution of UNECE;
- (c) Reducing Carbon Intensity in the Energy Sector;

- (d) A New Role for Gas in a Green economy; and
  - (e) UNECE Pathways to Sustainable Energy: Bureau-led Discussion on the Committee role in the context of the Decade of Sustainable Energy for All (SE4All).
5. These five themes will explore the sustainability challenges to be addressed by the energy sector and how UNECE can contribute to sustainable development and achieving a low carbon economy.

#### **Item 4: Cooperation and coordination with other Sectoral Committees of the Commission**

6. The secretariat will inform delegates on activities of common interest with other Sectoral Committees of the Commission.

#### **Item 5: Cooperation and coordination with other intergovernmental and non-governmental organizations**

7. The Committee will be briefed on cooperation with other intergovernmental and non-governmental organizations, industry associations and the business community. Country representatives and other major stakeholders will provide their views on cooperation with other relevant United Nations programmes and agencies, as well as other relevant organizations, to achieve synergies and complementarity of efforts and to avoid overlap and duplication.
