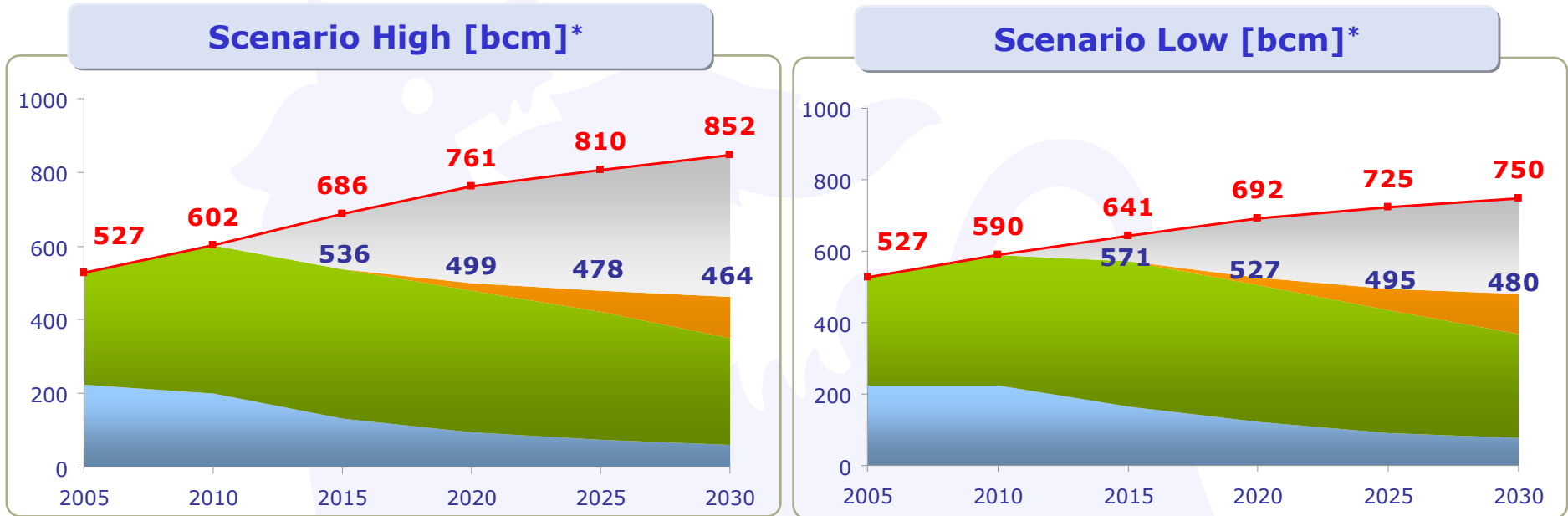

- Postponed phase-out of nuclear plants

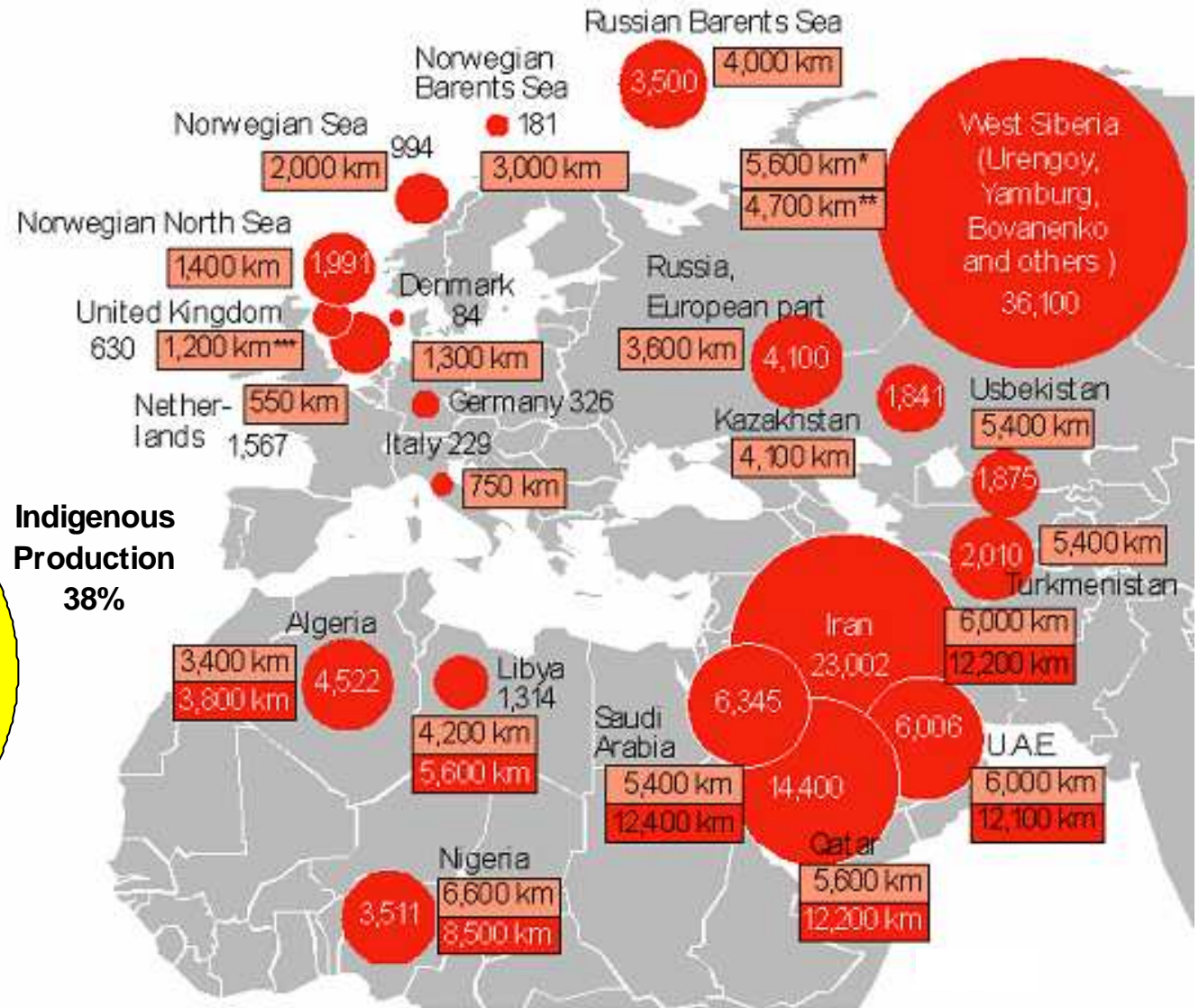
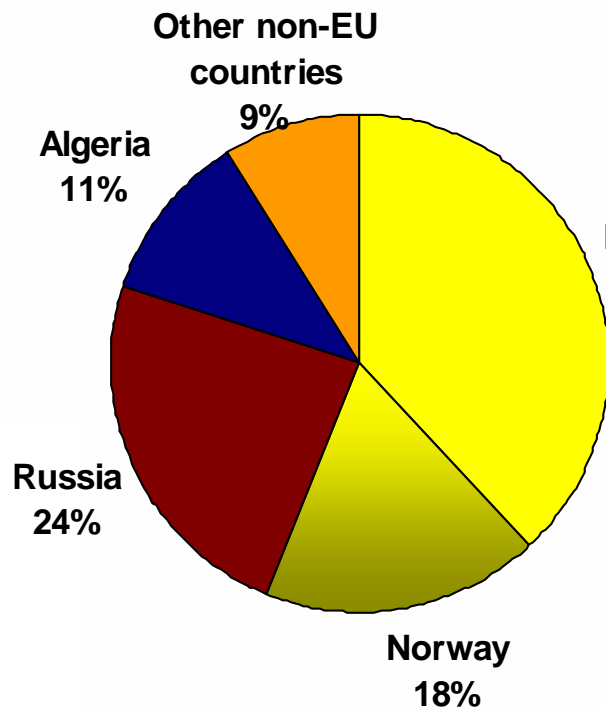

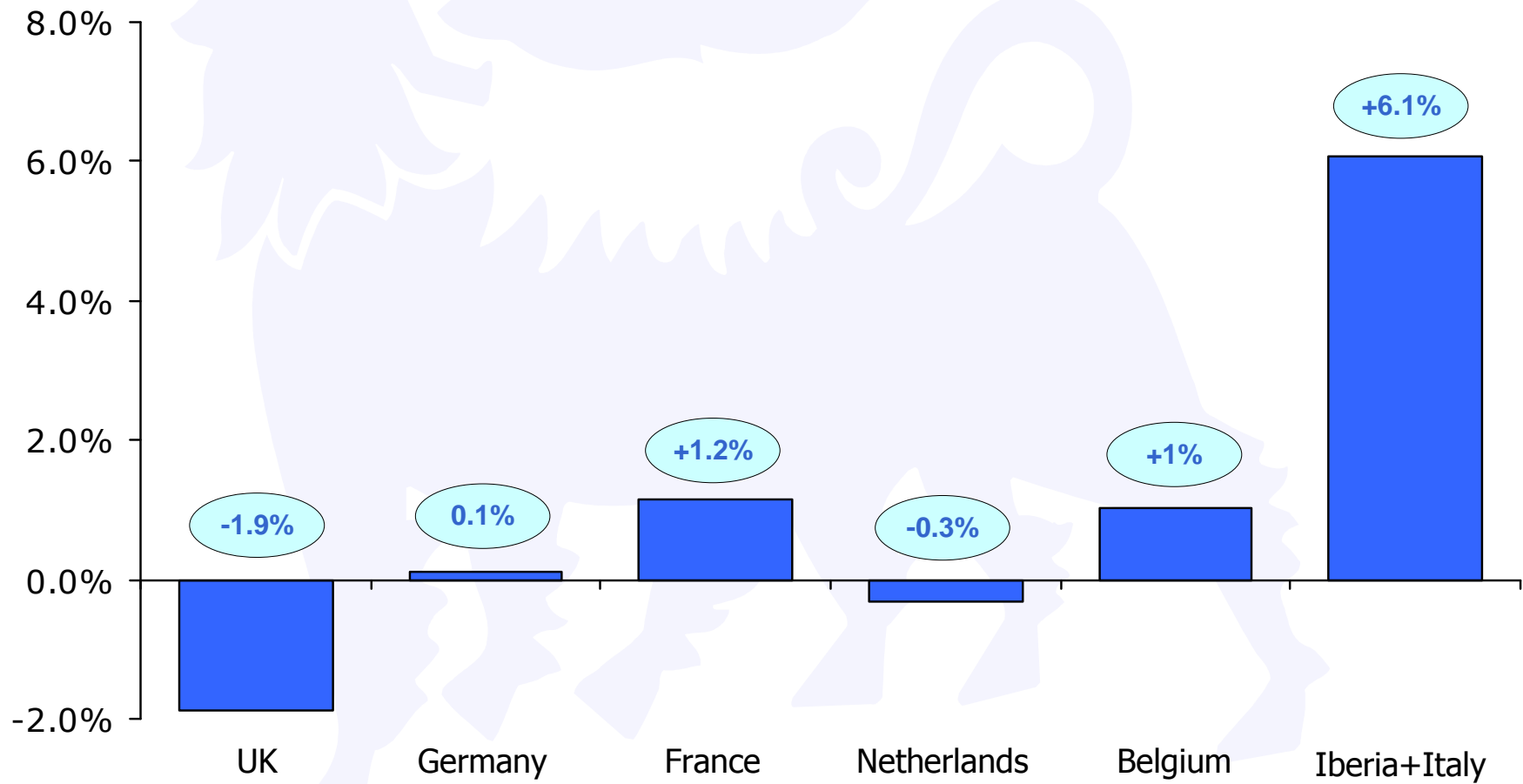
Gas resources are increasingly distant, and Europe is very dependent on external supply

South Stream Project

- ✚ A further step in the implementation of the Eni-Gazprom Agreements
- ✚ New pipelines from Russia to EU across the Black Sea
- ✚ Transport capacity will be defined through technical and market analysis
- ✚ More than 900 km in the off-shore section, reaching a depth of more than 2000 metres
- ✚ Routes under evaluation for the on-shore section from Bulgaria
- ✚ Use of most advanced technologies available, in the utmost respect of environmental safeguard requirements

South Stream: a European Project

- ✚ Increases the Gas import capacity towards the European Union
- ✚ Expansion and improvement of the EU Gas Transmission network
- ✚ Increases the interconnections between East and West EU
- ✚ Increases the flexibility of the European Gas system
- ✚ Project illustrated to the European Commission
- ✚ South Stream Project is not meant to interfere at all with other gas projects but is complementary to them in diversifying gas routes

It is a significant step to increase European gas security of supply

South Stream: a European Project

- ✚ The project is part of the European strategy to ensure security of gas supply
- ✚ The routes are in line with the EU strategic priority axis;
- ✚ The project will contribute to the development of the gas market in the Balkan area
