# Following up on the Batumi Initiative on Green Economy (BIG-E): sharing knowledge and good practices

**ORGANIZING PARTNERS:** the United Nations Economic Commission for Europe (UNECE), the United Nations Environment Programme (UN Environment) and the Green Growth Knowledge Platform (GGKP), with support from the Swiss Federal Office for the Environment.

**ABOUT:** At the Eighth Environment for Europe Ministerial Conference (Batumi, Georgia, 8–10 June 2016), Ministers endorsed the Pan-European Strategic Framework for Greening the Economy, which provides a common vision and objectives for the green transition in the region. At the Conference, Ministers also launched the Batumi Initiative on Green Economy (BIG-E) that consists of voluntary commitments to operationalize the Strategic Framework until 2030. At present, 113 commitments were submitted by 24 countries and 12 organizations to take concrete actions for moving towards greener and more inclusive economic patterns. BIG-E remains open for more stakeholders to join.

This side event will provide an overview of actions committed by countries and organizations under the BIG-E and will discuss the progress some countries and organizations have made since Batumi, including opportunities and challenges they have so far encountered. It will introduce participants to the BIG-E database on the Green Growth Knowledge Platform (GGKP), along with the opportunities it offers to promote and disseminate the Strategic Framework and the BIG-E in the pan-European region and beyond.

The event will conclude with a discussion of how to support countries in achieving their BIG-E commitments, which will include the presentation of the mapping of organizations' and donors' activities on green economy in the region.

The event is open to Member States and other stakeholders and an interactive Q&A session will offer the opportunity to gain insights and suggestions.
