The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning another Party's compliance with its obligations under the Convention, as provided for under paragraph 15 of the annex to decision I/7 of the Meeting of the Parties.

**Item 5. Submissions by Parties concerning their own compliance**

The Committee is expected to consider, in accordance with the relevant procedures, any submissions made by Parties concerning their own compliance with the obligations under the Convention, as provided for under paragraph 16 of the annex to decision I/7.

**Item 6. Referrals by the secretariat**

The Committee is expected to consider, in accordance with the relevant procedures, any referrals made by the secretariat concerning possible non-compliance by individual Parties with their obligations under the Convention, as provided for under paragraph 17 of the annex to decision I/7.

**Item 7. Communications from members of the public**

The Committee is mandated to consider, in accordance with the relevant procedures, communications from the public, as provided for under chapter VI of the annex to decision I/7.

- (a) The Committee is expected to resume its preparation of draft findings and, if appropriate, recommendations with respect to communication ACCC/C/2007/21 (European Community).
- (b) The Committee is expected to discuss the content of communication ACCC/C/2007/22 (France). In accordance with chapter IX of the annex to decision I/7, the Party concerned and the communicant are entitled to participate in the discussion on the subject matter of the communication, though not in the preparation or adoption of any findings, measures or recommendations of the Committee.
- (c) The Committee is expected to consider any new information received with regard to communications ACCC/C/2008/23 (United Kingdom), ACCC/C/2008/24 (Spain) ACCC/C/2008/26 (Austria), ACCC/C/2008/27 (United Kingdom) and ACCC/C/2008/28 (Denmark).
- (d) The Committee will discuss any new communications received sufficiently in advance of the meeting, in particular with respect to their admissibility and any issues that may need to be raised with the Party concerned.
- (e) The Committee may discuss any other issues related to communications.

**Item 8. Matters arising from the Meeting of the Parties, including follow-up on specific cases of non-compliance**

The Committee will be invited to discuss any progress with regard to implementation of decisions III/6, III/6a, III/6b, III/6c, III/6d, III/6e and III/6f. Pursuant to paragraph 8 of decision

III/5 of the Meeting of the Parties, the Committee will also review the position regarding the submission of reports by the States that were Parties at the time of the deadline for submission of the implementation reports and that failed to submit such reports to the secretariat.
