The Working Group on Strategies and Review is expected to continue considering options for revising the Protocol on Persistent Organic Pollutants (POPs), taking into account the decisions of and feedback from the Executive Body's twenty-sixth session. The Working

Group may be invited to further consider the amendments to the Protocol proposed by the European Union and Norway.

The Working Group will have before it a working document containing options for revising the Protocol that was prepared by the Working Group at its forty-first and forty-second sessions and amended on the basis of the decisions of the Executive Body made at its twenty-sixth session.

On the basis of the informal document prepared by the ad hoc group of technical experts in parallel to the forty-second session of the Working Group, the Working Group is also expected to consider: (a) the proposed amendments to annexes IV and V to the Protocol on POPs; (b) proposals for best available technology for new substances (PeCB, PCN and HCBD<sup>3</sup>); and (c) reduction of emissions of POPs from the waste treatment of electronic and electrical equipment, furniture and car interiors.

#### Item 4: Options for revising the Gothenburg Protocol

Tentative timing: Thursday, 12 March, morning

The Working Group will have some preliminary discussions on options for revising the Gothenburg Protocol, in advance of the Working Group session in April at which the main discussions on revising the Protocol will take place. In the time available, the Working Group may wish to explore preliminary views on options to increase the flexibility related to existing installations in countries of Eastern Europe, Caucasus and Central Asia (EECCA) and South-Eastern Europe (SEE), in order to help facilitate those countries' ratification of a revised protocol. It may also wish to initiate discussions on the different options to address the issue of non-binding aspirational targets for emission reductions for the year 2050. The Chair of the Task Force on Integrated Assessment Modelling will report on the preliminary outcome of a workshop on this issue, scheduled for February 2009. The Working Group may also wish to collect possible suggestions on how to deal with methane.
