I. Introduction

1. The Seventh “Environment for Europe” (EfE) Ministerial Conference will begin at 2 p.m. on Wednesday, 21 September 2011, and end at 6 p.m. on Friday, 23 September, lasting two-and-a-half days in total.
2. The two main themes of the Conference are: *sustainable management of water and water-related ecosystems*; and *greening the economy: mainstreaming the environment into economic development*. The Conference will address several agreed “questions for discussion” (see section II of the present document) under these two main themes, as well as under a cross-cutting theme, *sustainable management of water and greening the economy* (i.e., there will be three thematic segments in total).
3. The Conference will be chaired by the Minister of Environmental Protection of Kazakhstan. Each thematic segment will be chaired by a minister from a member State of the United Nations Economic Commission for Europe (ECE).
4. To enhance interaction between delegates, each of the three thematic segments of the Conference will consist of two parts:
 - A one-hour plenary session; followed by
 - A two-hour multi-stakeholder round table organized in three parallel sessions.

* The present document was submitted late due to the need to consult with partners.

5. Each plenary session will comprise several keynote addresses by different stakeholders in order to kick off the discussion in the round tables. The keynote addresses will focus on one or more of the “questions for discussion” identified for each of the thematic segments. Subsequent discussions will take place in the round table. Each parallel session of a given round table will address the same questions but, given the different participants involved, different perspectives may emerge in the discussions.
6. The consolidated results of the discussions from each thematic segment (both plenary and round-table sessions) will be presented by the respective chairs on the last day of the Conference and will serve as input into the Chair’s Summary of the Conference.
7. The official languages of the Conference are English, French and Russian (En, Fr, Ru). Simultaneous interpretation for these languages will be provided during the plenary sessions and during one of the parallel sessions of each round table. The two other parallel sessions of each round table will have simultaneous interpretation in English and Russian only.
8. The Conference agenda and documents (official and for information purposes) are available on the ECE website (<http://www.unece.org/env/efe/Astana/documents.html>). With regard to the Astana Water Action, countries were invited to register their commitments to water actions before the Conference; more information is available on the website.
9. To minimize the use of natural resources, **the Astana Ministerial Conference will be a paperless event**. In order to considerably diminish the printing of documents for the Conference, all Conference documents will be made available on the ECE website. Conference participants are encouraged to download them in electronic format and, if necessary, print them. Only documents produced during the preparatory meeting of the Committee and the Conference (e.g., the Ministerial Declaration and the Chair’s Summary) will be distributed, with two hard copies per delegation.
10. The host country will provide the necessary technical equipment (electric sockets and Wi-Fi Internet connection) to enable the use of laptops in the Conference plenary hall. Given financial resource constraints, the host country invites participants to bring their own laptops to the Conference.

Guidance notes for speakers and arrangements for round tables

A. Statements and interventions from the floor under agenda item 2

1. The Conference will address four main issues under agenda item 2: “From Dobříš to Astana: 20 years of pan-European cooperation”; the “Green Bridge” Partnership Programme; Europe’s Environment Assessment of Assessments; and the *Second Assessment of Transboundary Rivers, Lakes and Groundwaters in the UNECE Region*.
2. Following the four presentations, ministers and high-level representatives of the private sector and civil society will have the opportunity to make statements or interventions from the floor of up to three minutes. These statements or interventions may cover one or more of the four issues discussed under this agenda item.
3. Several speakers have asked to make statements or interventions. They are listed in a separate addendum to the present document, which will be regularly revised up until the Conference.
4. Final copies of statements and interventions made should be sent to the ECE secretariat (efe@unece.org) after the Conference for posting on the website.

B. Keynote speakers under agenda items 3, 4 and 5

5. Each keynote speaker will have up to five minutes for delivering a keynote address. The speech will be made from the lectern situated on the podium. For a more efficient use of time, seats for the keynote speakers will be reserved in a designated area close to the lectern. The Chair of the thematic segment will invite speakers to deliver their keynote address in accordance with the established order as per section II of the present document. The necessary technical equipment will be provided for PowerPoint presentations. Nonetheless, the five-minute time limit must be respected and it is therefore suggested that any PowerPoint presentation should be limited to 5 slides.
6. Keynote speakers are invited to submit to the ECE secretariat (efe@unece.org) a copy of their keynote address as soon as possible and not later than Tuesday, **13 September 2011**. The secretariat will provide these copies to the interpreters and also use them to extract the key messages for the Chair’s Summary of the Conference. The entire Chair’s Summary will be made available at the end of the Conference.
7. Final copies of the keynote addresses should be sent to the ECE secretariat (efe@unece.org) after the Conference to be posted on the website.

C. Arrangement for round tables under agenda items 3, 4 and 5

8. A round-table parallel session will comprise up to 30 participants, including ministers and heads of delegation of ECE member States, intergovernmental organizations (IGOs), regional environmental centres (RECs), NGOs and private sector representatives. NGOs and the private sector should be represented at the highest level, with the latter represented preferably by chief executive officers. To allow for participation of each of the 56 ECE member States in round-table discussions, the composition of each of the parallel sessions will be as follows:

- (a) ECE member States will have up to 19 seats;

- (b) IGOs will have up to 2 seats;
- (c) RECs will have up to 2 seats;
- (d) NGOs will have up to 4 seats; and
- (e) Private sector representatives will have up to 4 seats.

9. The list of round-table participants is presented in a separate addendum to the present document, which will be regularly revised up until the Conference.

10. In addition, some 200 registered participants in the Conference will be accommodated in each of the parallel sessions to participate as observers to the round-table discussions. If time permits, these participants will be given the opportunity to pose questions to the round-table participants.

11. Each of the round-table's parallel sessions will open with introductory remarks by the moderator. Participants in the round table will be invited to engage actively in the discussion, and to address the agreed questions for discussion. In their interventions, participants can address one or more questions for discussions and/or react to interventions of others.

12. Speeches that have been prepared in advance are strongly discouraged during the round tables; instead, participants should exchange views on the theme under discussion. To allow each participant at the round table to intervene at least once during the discussion, the time limit for interventions will be three minutes.

13. Following the discussion, the moderator will highlight key points to be brought to the attention of the Conference plenary (agenda item 6).
