II. Annotations

1. The main objective of the seventh meeting of the Working Group on Water and Health under the Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes is to review the implementation of the programme of work for the period 2014–2016, adopted at the third session of the Meeting of the Parties to the Protocol (Oslo, 25–27 November 2013), and to provide guidance on its further development, with particular consideration to the financial situation.
2. The meeting will begin on Wednesday, 26 November 2014 at 10 a.m. and will close on Thursday, 27 November 2014 at 5 p.m. It will be held back to back with the tenth meeting of the Protocol's Compliance Committee,¹ which will take place in Geneva on 25 November 2014, and a meeting of the Bureau on 28 November 2014.
3. The working languages of the meeting will be English, French and Russian.
4. All relevant documentation for the meeting of the Working Group will be available online from the United Nations Economic Commission for Europe (ECE) website.²

1. Election of officers

5. The Working Group will elect its Chair and Vice-Chair(s) for the triennium 2014–2016.

2. Adoption of the agenda

Tentative timing: Wednesday, 26 November, 10.05–10.10 a.m.

6. The Chair of the Working Group on Water and Health will open the meeting and welcome participants. The Working Group is expected to adopt its agenda as set out in the present document.

3. Progress in the ratification process

Tentative timing: Wednesday, 26 November, 10.10–10.30 a.m.

7. As of 15 August 2014, the following 26 countries were Parties to the Protocol on Water and Health: Albania, Azerbaijan, Belarus, Belgium, Bosnia and Herzegovina, Croatia, Czech Republic, Estonia, Finland, France, Germany, Hungary, Latvia, Lithuania, Luxembourg, Netherlands, Norway, Portugal, Republic of Moldova, Romania, Russian Federation, Serbia, Slovakia, Spain, Switzerland and Ukraine. There were no new accessions since the third session of the Meeting of the Parties to the Protocol.

8. Representatives of Signatories and other States not yet Party to the Protocol will be invited to report on any recent or anticipated developments in their respective countries with respect to becoming a Party to the Protocol.

4. Setting targets, implementing measures and reporting under the Protocol

Tentative timing: Wednesday, 26 November, 10.30 a.m.–1 p.m. and 3–3.30 p.m.

(a) Setting targets and implementing measures

9. The Chair of the Task Force on Target Setting and Reporting will report on the outcomes of the seventh meeting of the Task Force (Geneva, 4 July 2014), in particular with regard to the exchange on the progress in setting targets and implementing them.

10. The Working Group will be invited to provide comments as needed and to report on the advancement of the target-setting process in their countries, if there have been any significant developments.

11. A representative of Kazakhstan will present the outcomes of the National Workshop on the Protocol on Water and Health for Kazakhstan held in Borovoe on 23 and 24 April 2014. A representative of Turkmenistan will likewise present the outcomes of a similar event for Turkmenistan scheduled to be held in Ashgabat in October 2014.³

12. The Chair of the Task Force will also inform the Working Group about the decision to establish an informal review group to work on an addendum to the *Guidelines on the Setting of Targets, Evaluation of Progress and Reporting*⁴ as well as to define the scope of a possible further revision of the guidelines after the fourth session of the Meeting of the Parties to the Protocol, scheduled to take place in 2016.

13. The Working Group will also be informed about developments in the framework of the World Health Organization (WHO)/United Nations Children's Fund (UNICEF) Joint Monitoring Programme for Water Supply and Sanitation (JMP) and the UN-Water Global Analysis and Assessment of Sanitation and Drinking Water (GLAAS), in particular the JMP progress report for 2014 and development of country highlights for GLAAS. In addition, the proposed targets and indicators for drinking water, sanitation and hygiene linked to the post-2015 sustainable development goals will be presented.

14. The WHO Regional Office for Europe (WHO/Europe) secretariat will update the Working Group about the planned capacity-building activities on global monitoring programmes in Serbia and Azerbaijan. A representative of Serbia will inform the Working Group about the planned national workshop on target setting and reporting in Serbia.

15. A representative of Romania will inform the Working Group about the planned activities on public participation in implementing the Protocol and will invite the Working Group to discuss possible ways to promote and use the *Guide to Public Participation under the Protocol on Water and Health*.⁵

(b) Improving the quality of reporting

16. The Working Group will be briefed on the main conclusions from the regional workshop on linkages with other existing monitoring and reporting mechanisms related to water and health, which was held in Geneva on 3 July 2014.

17. The Working Group will be informed about the relevant decisions of the seventh meeting of the Task Force on Target Setting and Reporting, in particular the decision to revise the guidelines and template for summary reports by the eighth meeting of the Task Force, scheduled to take place on 2 and 3 July 2015. The Working Group will be invited to review the Task Force's decisions.

5. Prevention and reduction of water-related diseases

Tentative timing: Wednesday, 26 November, 3.30–5 p.m.

18. The WHO/Europe secretariat together with representatives of Georgia and Hungary, lead Parties for programme area 2.4, on strengthening water, sanitation and hygiene (WASH) in schools, will inform the Working Group about the outcomes of the meeting on advancing WASH in schools (Bonn, 18–19 September 2014), as well as the findings of a review of available evidence related to the situation of WASH in schools in the pan-European region.

19. The representatives of Georgia and Hungary will also present the outcomes of a strategic planning meeting, including the plans for future work for 2014–2016 under this thematic area. The Working Group will be invited to discuss proposed activities.

20. The WHO/Europe secretariat together with representatives of Belarus and Norway, lead Parties for programme area 2.1, on strengthening water-related disease surveillance, outbreak detection and management, will inform the Working Group about the outcomes of the meeting on strengthening surveillance of water-related diseases (Bonn, 23–24 October 2014), as well as key findings of a literature review on water-related diseases and outbreaks in the pan-European region.

21. The representatives of Belarus and Norway, the lead Parties for programme areas 2.1 and 2.3, on supporting cost-effective drinking-water quality surveillance, will present the outcomes of a strategic planning meeting, including the plans for future work for 2014–2016 under these thematic areas. The Working Group will be invited to discuss proposed activities.

23. The WHO/Europe secretariat will inform the Working Group about the outcomes of a subregional meeting for countries of Eastern Europe, the Caucasus and Central Asia (Bishkek, 26–27 June 2014) under the joint auspices of the WHO International Small Community Water Supply Network and the Protocol on Water and Health.

7. Safe and efficient management of water supply and sanitation systems

24. The WHO/Europe secretariat will inform the Working Group about the key outcomes of the subregional workshop for countries of Eastern Europe, the Caucasus and Central Asia on building capacities for the development of water safety plans (Bishkek, 24–25 June 2014).

25. The Working Group will be informed about the outcomes of the water safety plan advocacy workshop and capacity-building training organized jointly by Oxfam Great Britain and WHO/Europe in Tajikistan (Dushanbe, 11–14 August 2014).

26. The ECE secretariat will inform the Working Group about the plans to conduct, jointly with International Water Association (IWA) and WHO/Europe, a training session on water safety plans for water operators within the project “Implementation of targets and target dates set under the Protocol on Water and Health in the Republic of Moldova”, funded by Swiss Agency for Development and Cooperation.

informed about ongoing and foreseen activities to raise awareness on the challenges faced in achieving equitable access to water and sanitation, to assessing the equity of access to water and sanitation in some countries and to developing action plans to address inequities in access.

29. Representatives from Hungary and the Republic of Moldova will report on progress made in assessing the situation of access to water and sanitation in terms of equity at the national level in their countries.

30. The Working Group will be invited to express interest in engaging in the development of a coordinated baseline analysis of the equity of access to water and sanitation, using as a basis *The Equitable Access Score-card: Supporting policy processes to achieve the human right to water and sanitation*.⁹
