



THIRD MEETING OF THE TASK FORCE ON THE WATER-FOOD- ENERGY-ECOSYSTEM NEXUS IN TRANSBOUNDARY BASINS UNDER THE WATER CONVENTION

At its sixth session (Rome, 28–30 November 2012), the Meeting of the Parties to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes included an assessment of the water-food-energy-ecosystems nexus in the Convention's programme of work for 2013–2015. This decision was in recognition of the possibility that friction and potential conflicts in water management might result from tensions between sectoral objectives, unintended consequences of resource management and trade-offs between sectors, both at the national and the international level. By assessing the situation in transboundary basins jointly and improving the knowledge base, synergies can be achieved and potential solutions identified.

The Parties decided that the Task Force on the Water-Food-Energy-Ecosystems Nexus and the Working Group on Integrated Water Resources Management would be the responsible bodies for the assessment.

The third meeting of the Task Force will have the following objectives:

- Provide an overview of the status of preparations;
- - Discuss the findings and the experience from the basin assessments;
- - Review draft contents the overall stocktaking report from the nexus assessment;
- - Agree on the concluding steps in the process to complete the presentation of findings for publication;
- - Discuss possible follow-up activities for the Convention's programme of work 2016–2018.

The Task Force Meeting is supported by the Finnish Ministries of Foreign Affairs and the Environment, as well as the German Ministry for the Environment, Nature Conservation, Building and Nuclear Safety. The preparation process is also supported financially from the Swiss Agency for Development and Cooperation.

SESSION 6: Next steps in the nexus assessment under the Water Convention and possible follow-up activities in the next work plan

The next steps and the timeline for finalising the nexus assessment on time for the 7th Meeting of the Parties will be discussed and agreed upon.

In addition, a look will be taken back at the past 3 years to draw some lessons learnt from the process. It will also be discussed what can be done to promote responses to the conclusions and recommendations.

In at least some basin assessments, more detailed analytical and modelling work is expected to continue beyond autumn 2015. Therefore, the 2015 report is not expected to reflect the full breadth and depth of the nexus assessment work.

Discussion on the nexus for the next work programme under the Water Convention (2016-2018)

The nexus was considered one of the priorities for the next programme of work under the Water Convention, 2016–2018, in the ninth meeting of the Working Group on Integrated Water Resources Management (Geneva, 25–26 June 2014) and has been included in the draft programme of work being proposed by the Bureau. The Chair will present the proposal of the Bureau as a basis for discussion on possible follow-up activities on the nexus.

Links to relevant global processes such as the proposed Sustainable Development Goals as well as to other programme areas of the Convention such as benefits of transboundary cooperation and climate change will also be discussed.
