



# PROCEEDINGS OF THE MEETING OF THE STEERING COMMITTEE OF THE NATIONAL POLICY DIALOGUE IN WATER SECTOR OF UKRAINE

November 28, 2017  
Kyiv, Ukraine

National Political Dialogues (NPD) became the main tool within the framework of the Water Initiative of the European Union in the countries of Eastern Europe, Caucasus and Central Asia in recent decades in order to promote water policy reforms.

The purpose of this Dialogue in Ukraine is:

Discussion and development of proposals on legislative and institutional changes in Ukraine in the field of water policy, including implementation of the Association Agreement between Ukraine and the European Union:

- preparation of the National Water Strategy,
- discussion of the draft Concept of reforming State Agency for Water resources,
- presentation of draft order of Cabinet of Ministry of Ukraine about new water monitoring system in Ukraine preparing in accordance with EU WFD,
- status of implementation of Urban waste water EU Directive and Nitrate EU Directive in Ukraine.

Presentation and discussion the results of the Situation Analysis underlay both review of the targets and update of the Action Plan for Implementation of the Protocol of Water and Health under UNECE Water Convention.

The Meeting of the Steering Committee for the National Dialogue on Water Policy was chaired by **Mr. Mykola Kuzio**, Deputy Minister of Ecology and Natural Resources of Ukraine on European Integration. About 90 representatives of central executive authorities, scientific institutes, international organizations, active technical assistance projects, financial institutions and the public participated in the Meeting.

**Mr. Mykola Kuzio** emphasized the importance of the continuing of the process of political dialogues in Ukraine between all interested national stakeholders, as well as international projects in order to fulfil Ukraine's obligations under the EU-Ukraine Association Agreement.

There were four sessions on the NPD meeting.

**First session: «Governance reforms in the water sector»** was dedicated to approaches to reforms in the sphere of management and control of water resources use, protection and recovery. Invited speakers were proposing approaches to reforming the water sector, including - in particular - reforming the State Water Agency. The participants were presented the draft concept of water sector reforms by ensuring introduction of river basin-based integrated water management and introduction of fundamental European market-based principles for provision of water management services. In critical terms, the said reform is based on successful implementation of provisions of the Water Framework Directive, as well as on opportunities to introduce basic market-based arrangements for provision of irrigation and drainage services (and fulfilment of other management functions delegated to the State Water Agency by the due legislation). According to outcomes of the preparatory meeting of the Dialogue (held in early 2017), the said issues will be considered in the context of the future National Water Strategy and as component parts of the Strategy. The participants were discussing the situation of establishment and launching of Basin Councils (according to Art. 13 of the Water Code of Ukraine and Order # 23 of MENR of 26.01.2017) as key river basin management bodies in Ukraine, as well as approaches to development of River Basin Management Plans.

**Session two: «Reforming the system of water monitoring in Ukraine»** was dedicate the water monitoring procedures - the ones recently developed by MENR and submitted for review of relevant central executive bodies (referred hereinafter to as CEBs). Particularly important aspects include institutional, technical, information and human capacity of water monitoring actors for ensuring implementation of the procedures that comply with WFD requirements and introduce development of relevant basin-based water monitoring programs. At the same time, in order to make informed environmental governance decisions, it is necessary to ensure accuracy and reliability of environmental data through ensuring relevant metrological control over quality and accuracy of quantitative measurements. Pending issues also include processing of raw data for production of reliable information to inform decision makers at the level of governance. Discussion of the above aspects and accounting for experience of European partners allow to frame a long-term vision of the aspects proposed for discussion.

**Session tree: «Drinking water and sanitation».** According to findings of the last brief report of Ukraine on implementation of the Protocol on Water and Health in 2016, Ukraine started to review its national targets with support of UN ECE and accounting for new international frameworks and commitments: Sustainable Development Goals and EU-Ukraine Association Agreement. According to the Guidelines on Setting Targets, Evaluation of Progress and Reporting under the Protocol on Water and Health, in October 2017, Ukraine started to develop the Situation Analysis for 2015, in 20 target areas. According to Article 6.2 of the Protocol on Water and Health, results of the Situation Analysis underlay both review of the targets and update of the Action Plan for Implementation of the Protocol (approved in 2003). The results will be presented at the session.

The session was also focus on issues of access to safe drinking water of good quality, problems of rural water supply and sanitation, and associated impacts of deregulation processes.

It is worth to note the following contemporary trends observed:

- Weaker fulfilment of state functions in the sphere of water monitoring (including drinking water monitoring) and almost completely cancelled fulfilment of functions of state control/supervision in the sphere of drinking water supply and sanitation (the moratorium for regular inspections up to January 1, 2018),
- Non-compliance of Ukraine with requirements of the Protocol on establishment and/or strengthening the system of control/supervision and early prevention of water-related diseases;
- Lack of state policies on ensuring quality and safety of drinking water and sanitation, a serious and lengthy failure to address already accumulated problems in the sphere of



access to sanitation and wastewater disposal, and issues of water resources pollution in Ukraine,

- Lack of a balanced state tariff policies for protection of consumer rights and ensuring affordable water supply and sanitation services; lack of appropriate, relevant and complete information for consumers on water quality and available water sources.

All the above factors affect efficient decision-making in the sphere, accounting for global political frameworks - Sustainable Development Goals and regional commitments for European integration and implementation of EU water directives.

**Session four: "Water and agriculture"**. According to Decree # 847-r of the Cabinet of Ministers of Ukraine of September 17, 2014 (on Implementation of the Association Agreement with Ukraine, on the One Part, and the European Union, the European Atomic Energy Community and their Member States, on the Other Part), the Ministry of Ecology and the Ministry of Agricultural Policy were authorised to implement a number of actions for implementation of the Council Directive 91/676/EEC of 12.12.1991 Concerning the Protection of Waters against Pollution Caused by Nitrates from Agricultural sources as amended by Regulations 1882/2003/EC and 1137/2008/EC (referred hereinafter to as the Nitrates Directive). According to the Action Plan for Implementation of the Nitrates Directive, the Ministry of Ecology, the Ministry of Agricultural Policy, the State Water Agency and other CEBs are responsible for its implementation. In particular, there are some problems of cooperation between these CEBs and it is necessary to involve agro-businesses into the process. The session was focused on enhancement of cooperation between the CEBs for implementation of the Directive and the session participants were presented materials developed in the framework of fruitful cooperation between the Ministry of Ecology and APENA project experts.
