



PRTR Protocol to the Aarhus Convention 3rd Meeting of the Working Group of the Parties (Geneva, 20-21 November 2013) - Position by the EU and its Member States -

Item 4. Promotion and capacity-building

The EU and its Member States would like to thank the secretariat and the Bureau for efforts in promoting and implementing the Protocol, providing technical assistance, as well as preparing related documents.

We acknowledge the progress made in providing technical assistance through existing mechanisms and particularly the effort put into strengthening synergies with other instruments, bodies and organisations. We encourage the Secretariat to continue its efforts in this respect.

<u>Item 4(a) – Synergies with United Nations Economic Commission for Europe multilateral environmental agreements and other partners</u>

The EU and its Member States believe that synergies with other organisations and multilateral environmental agreements (MEAs) are very important, since they enhance public access to information on global environmental issues and facilitate public participation in environmental decision-making.

We believe that the joint global round table organised by the secretariat of the UNECE Protocol on PRTRs and the OECD in cooperation with UNITAR represents not only a great opportunity to share both successes and challenges in implementing the PRTR Protocol, but also an opportunity to identify problematic areas and to set guidelines for future actions towards the implementation of PRTRs.

Item 4(b) – Subregional workshops

The EU and its Member States would like to thank the secretariat for preparing the report on the subregional workshop "Get Your Right to a Healthy Community" on Pollutant Release and Transfer Registers in South-Eastern Europe that took place in Sarajevo on 28 and 29 May 2013. This report provides information on the challenges to PRTR development faced by these countries, and identifies the solutions needed for accession to the Protocol by countries of the subregion. We believe that the outcomes from the workshop will be very valuable in the ongoing development of PRTRs.

<u>Item 4(c) – Provision of technical assistance</u>

The EU and its Member States would like to thank Belarus and Armenia for their draft proposal on activities for promotion of the PRTR Protocol in the countries of Eastern Europe, the Caucasus and Central Asia.

We acknowledge the efforts made and welcome the steps taken so far. The current draft proposal is wide-ranging and should be developed further to enable detailed discussion. This would involve specifying each of the proposed activities, including the identification of possible outcomes of the events and the costs of each activity. The structure of the work programme of the Protocol (document ECE.MP.PRTR.WG.1.2013.10) could be taken as an example for further work in this direction.

The proposal should also specify what the gaps are in relation to having a fully functioning PRTR system within each country jurisdiction covered.

Furthermore, paragraphs 273 and 277 of the Rio+20 outcome document "*The future we want*" seem relevant. We expect that the report of the intergovernmental preparatory working group² regarding the facilitation mechanism will also address some of the issues raised in the draft proposal and could provide possible solutions to the challenges identified.
