1. Do you consider that any of the issues raised in your communication have been resolved by the amendments to the EIA Act adopted by the Czech Republic in 2015? If so, please indicate which ones.
  2. Do you consider that since the submission of your communication there have been any developments (either positive or negative) in the practice of administrative authorities and the courts of the Czech Republic relevant to the issues raised in your communication? If so, please describe.
  3. Do you consider that the Czech Republic is still in non-compliance with article 6, paragraphs 3 and 8 of the Convention with respect to the original allegations made in your communication? If so, regarding which type of procedures and with respect to which categories of the public concerned (affected individuals, NGOs, etc.)? Please provide reasons for your answer.
  4. Do you consider that the Czech Republic is still in non-compliance with article 9, paragraphs 2, 3 and 4 of the Convention with respect to the original allegations in your communication? If so, regarding which type of procedures, acts or omissions and in which respects, and, if relevant, for which categories of the public concerned (affected individuals, NGOs, etc.)? Please provide reasons for your answer.
