Subject: WG: Decision V/9h (Germany) - information on new developments

Dear Ms. Marshall,

Today, the *Draft Bill Aligning the Environmental Appeals Act and other provisions to Stipulations of European and International Law* was deliberated in the Committees of the German Bundestag. The leading Committee on the Environment, Nature Conservation, Building and Nuclear Safety recommended to the German Bundestag to adopt the draft bill with a small number of small amendments. Please find attached for information purposes an extract of the current consolidated version of the Draft Bill in English, where all amendments have been marked. This unofficial document also contains short explanations of the amendments, as well as the motion for a resolution of the parliamentary groups of the CDU/CSU and SPD which was also adopted by the Committee today and submitted to the German Bundestag (page 6 of the document). Please find also attached the committee's relevant official documents in German (motion for amendments; motion for resolution).

The plenary session of the German Bundestag where the Draft Bill is likely to be adopted (including the proposed amendments) takes place on tomorrow's Thursday, 27 April. According to the official agenda, the Draft Bill will be deliberated at about 7 p.m.
