2. Relevant developments since the previous meeting of the Committee

The Chairman will inform the Committee about the outcome of the meeting of the Legal Board under the Meeting of the Parties to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes. The Legal Board is developing a compliance review mechanism under the 1999 Protocol on Water and Health.

The Committee will be invited to share any other information on relevant developments since its previous meeting not covered under other agenda items.

3. Other matters arising from the previous meeting

The secretariat will present progress in the preparation of a document on the main aspects of the compliance mechanism, including the Committee's modus operandi, procedures for submissions, referrals and communications, information gathering and on-the-spot appraisal, and on NGOs and the Compliance Committee.

4. Submissions by Parties concerning other Parties

The Committee is expected to consider, in accordance with the relevant procedures, any submission made by a Party concerning another Party's compliance with its obligations under the Convention, as provided for under paragraph 15 of the annex to decision I/7.

5. Submissions by Parties concerning their own compliance

The Committee is expected to consider, in accordance with the relevant procedures, any submission made by a Party concerning its own compliance with the obligations under the Convention, as provided for under paragraph 16 of the annex to decision I/7.

6. Referrals by the secretariat

The Committee is expected to consider, in accordance with the relevant procedures, any referral made by the secretariat concerning possible non-compliance by a Party with its obligations under the Convention, as provided for under paragraph 17 of the annex to decision I/7.

7. Communications from members of the public

The Committee is expected to consider, in accordance with the relevant procedures, any communications received from the public, as provided for under chapter VI of the annex to decision I/7.

8. Other information received by the Committee relevant to possible cases of non-compliance

The Committee is expected to consider any other information relevant to possible non-compliance brought to its attention.

9. Modus operandi

The Committee will be invited to discuss issues related to its modus operandi, including:

(a) Procedures for bringing submissions made according to paragraph 15 of the annex to decision I/7 to the attention of the Party concerned and the Committee;

(b) Procedures for dealing with requests for information, including requests made to Committee members, regarding details of communications, submissions and referrals; and

(c) Procedures for discussing communications, including issues arising from possible conflict of interest.

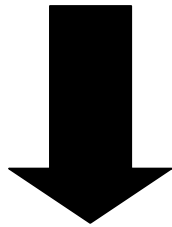
