### **PROVISIONAL PROGRAMME OF THE HIGH-LEVEL SEGMENT**

#### **Opening ceremony**

1. The high-level segment of the meeting will be opened and chaired by the Latvian Minister for the Environment. There will then be a welcome address by the Speaker of the Latvian Parliament, an opening address by the Executive Secretary of the United Nations Economic Commission for Europe and a message delivered on behalf of the Executive Director of the United Nations Environment Programme.

#### **Panel discussions**

2. The high-level segment will include three panel discussions during which ministers, distinguished speakers from international organizations and leading representatives of civil society will exchange views in a lively debate on topics of key relevance to the Convention and Protocol on Pollutant Release and Transfer Registers (PRTRs).

3. Each panel discussion will be chaired by a moderator who will introduce the panelists and moderate the discussion. Each panellist will be invited to make a short opening statement, after which the debate will be opened to the floor. During the debate, panellists will have the opportunity to react to statements of their fellow panellists and to respond to questions or comments from the floor.

#### **Agenda item 10: Celebrating the first 10 years: achievements, lessons learned and future challenges**

4. Panellists will share their views of the contribution that the Convention has made in its first 10 years within their area of expertise, both the successes and any particular challenges. They may also share more general perspectives on the significance of the Convention in its broader political context and their thoughts on future challenges. Invited panelists will come from a diverse range of experience and perspectives, including ministers and senior

representatives of regional organizations, the judiciary, the Convention's Compliance Committee and non-governmental organizations (NGOs).

5. The panel discussion will be followed by a general debate in which the draft long-term strategic plan is expected to serve as a key point of reference. Other reference documents for the general debate will include the two sets of national implementation reports (2005 and 2008) and the respective synthesis reports, and the capacity-building report.

#### **Agenda item 11: Global and regional initiatives to promote principle 10 of the Rio Declaration on Environment and Development**

6. A panel of invited experts will present their perspectives on how the experience in developing and implementing the Convention in the region can be used to promote progress in implementing principle 10 of the Rio Declaration in other regions and at the global level. The panel will include senior representatives of international organizations and the NGO community, working both inside and outside the UNECE region. A message on rights to information and participation in the context of human rights and the environment will also be delivered on behalf of the UN Special Rapporteur of the Human Rights Council on the adverse effects of the illicit movement and dumping of toxic and dangerous products and wastes on the enjoyment of human rights. The panel presentations will be followed by a general debate.

#### **Agenda item 12: Special session on the Protocol on Pollutant Release and Transfer Registers**

7. In the special session on the Protocol on PRTRs, a panel of senior representatives from governments, regional organizations, industry and the NGO community will share their views on the challenges to the implementation of the Protocol, including in particular those faced by countries with economies in transition, as well as the future steps needed to bring about the early entry into force of the Protocol. The panel debate will be followed by a general debate on the draft statement on the Protocol on PRTRs prepared by the Working Group of the Parties. Reference documents will include the reports and other documents of the Working Group on PRTRs and the draft statement. Ministers and Heads of delegation of Parties, Signatories and other States, as well as international, regional organizations and NGOs and other representatives of civil society will be invited to consider, revise as necessary and adopt the statement.
