**PROMOTING THE APPLICATION OF THE PRINCIPLES OF  
THE CONVENTION IN INTERNATIONAL FORUMS**

adopted at the third meeting of the Parties  
held from 11 to 13 June 2008 in Riga

*The Meeting of the Parties,*

*Recalling* article 3, paragraph 7, of the Convention, which requires each Party to promote the application of the principles of the Convention in international environmental decision-making processes and within the framework of international organizations in matters relating to the environment,

*Recalling also* decision II/4 through which the Meeting of the Parties adopted the Almaty Guidelines on Promoting the Application of the Principles of the Aarhus Convention<sup>1</sup> in International Forums,

*Welcoming* the work undertaken by the Task Force on Public Participation in International Forums under the leadership of France, and in particular the consultation process carried out by the Task Force on the Almaty Guidelines,

*Believing* that there is no need to revise the Almaty Guidelines at the present time,

*Recognizing* that significant work remains to be done to implement article 3, paragraph 7, of the Convention and that the principal focus of common work on this issue in the next intersessional period should be to assist Parties to do so,

*Underlining* the importance of increasing understanding of the challenges faced, and the good practices employed, by international forums with respect to public participation, through further exchange of experience between the Convention and other international forums,

1. *Decides* to continue to apply the Almaty Guidelines in an exemplary manner within the subsidiary bodies established under the Convention, including those related to the Protocol;
2. *Also decides* to extend in time the mandate of the Task Force, subject to the availability of human and financial resources, and requests it, with the assistance of the secretariat:
  - (a) To continue outreach to interested international forums, but in a more focused way, e.g. through joint workshops, on a bilateral or limited multilateral basis, or by inviting representatives of interested international forums to attend meetings of the Convention bodies,
  - (b) To prepare a document evaluating the outcomes of the consultation process on the Almaty Guidelines carried out by the Task Force in the last intersessional period and to circulate this to the international forums involved, together with information on proposed future activities on the topic;
  - (c) To prepare a compendium of case studies of good practice on promoting public participation in international forums for broad dissemination;
  - (d) To analyse the latest national implementation reports as well as other relevant national background information in order to review the Parties' efforts to implement article 3, paragraph 7, and on that basis to develop appropriate means of reporting to be integrated as appropriate in the general reporting requirements at the fourth ordinary meeting of the Parties;
  - (e) To organize a workshop or workshops for Parties to share their good practices and challenges regarding their efforts to implement article 3, paragraph 7;
3. *Encourages* outreach by individual Parties to non-governmental organizations, such as through regular national dialogues on policymaking in international forums and twinning initiatives between countries with experience and other interested countries;
4. *Also encourages* collaborative activities by groups of Parties to promote the Almaty Guidelines and the principles of the Convention in international forums whose practices do not presently reflect the Guidelines or the principles of the Convention;

5. *Requests* that the above activities be designed, where appropriate, to facilitate the participation of non-English speakers and to ensure the inclusion of a wide range of perspectives, including participants involved in other international forums and academia;
6. *Welcomes* the offer of France to continue to lead the work of the Task Force.
